3. To discuss cases of medical negligence and unethical conduct.

- (a) The Order of the Executive Committee in complaint No. 2739 of Smt. Anjali Goyal, w/o Shri. Ajay Goyal, r/o- A-21/38, Gangotri Vihar, House No.20, Gali No.10, West Ghonda, Delhi-110053, forwarded by the Directorate General of Health Services, Govt. of NCT. of Delhi, alleging medical negligence and professional misconduct on the part of Dr. Madhukar Prakash of Jeevan Jyoti Clinic and Hospital, GTB Chowk Dilshad Garden, Delhi-110095 in the treatment administered to complainant, was confirmed by the Delhi Medical Council.
- (b) The Order of the Executive Committee in complaint No. 2963 of Shri Santosh Agarwal r/o Flat 6, First Floor, Richmond Park Society, Vasundhara Sector-6, Near Bhagwan Budh Chowk, Ghaziabad, Uttar Pradesh-201012 alleging medical negligence on the part of Dr. Ashish Srivastava of Dharmashila Hospital, Dharamshila Marg, Vasundhara Enclave, Near New Ashok Nagar, Metro Station, Delhi-110096, in the treatment of complainant's mother Smt. Rukmani Devi, was confirmed by the Delhi Medical Council.
- (c) The Order of the Executive Committee in complaint No. 3077 of Dr. Priya Gupta, r/o- B-20/4, IInd Floor, West Jyoti Nagar, Shahdara, Delhi-110094, alleging professional misconduct on the part of Dr. Vishu Singhal, 1/7A, Daksh Road, Vishwas, Nagar, Shahdara, Delhi-110032, was confirmed by the Delhi Medical Council.
- (d) The Order of the Disciplinary Committee in complaint No. 2788- a representation from Police Station Bhajanura, seeking medical opinion on a complaint of Smt.

Salma w/o Shri Rahees Ahmed r/o H.No.D-587/A, Kabir Nagar, Delhi, alleging medical negligence on the part of doctors of Samra Hospital Pvt. Ltd. C-4/70, Yamuna Vihar Delhi in the treatment of complainant's husband Shri Rahees Ahmad, was confirmed by the Delhi Medical Council.

The Council further confirmed the punishment of removal of name of Dr. Abdul Khalique (Dr. Abdul Khalique, Delhi Medical Council Registration No.16900) and Dr. K.G. Singh (Dr. Krishna Gopal Singh, Delhi Medical Council Registration No.52546) awarded by the Disciplinary Committee for a period of 07 days.

The Council further observed that the Order directing the removal of name from the State Medical Register of Delhi Medical Council shall come into effect after 30 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (e) The Order of the Disciplinary Committee in complaint No. 2027- A representation from SHO Police Station, Greater Kailash, forwarded by the Medical Council of India seeking medical opinion in respect of death of Smt. Sunita, allegedly due to medical negligence in the treatment administered to the late Smt. Sunita at Agarawal Medical Center, E-234, Greater Kailash Part -1 New Delhi 110048 and Safdarjung Hospital, Ansari Nagar, New Delhi-110029, was confirmed by the Delhi Medical Council.

The Council further confirmed the punishment of removal of name of Dr. D.C. Aggarwal (Dr. Dinesh Chandra, Delhi Medical Council Registration No.4064) and Dr. Asheesh Lal (Dr. Asheesh Praveen Lal, Delhi Medical Registration No.19811) awarded by the Disciplinary Committee for a period of 07 days.

The Council further observed that the Order directing the removal of name from the State Medical Register of Delhi Medical Council shall come into effect after 30 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (f) The Order of the Disciplinary Committee in complaint No. 2663- A representation from the Police Station, Bindapur Delhi, seeking medical opinion regarding alleged medical negligence in the treatment administered to late Smt. Asha at Sunand Hospital, G-17, Kiran Garden, Uttam Nagar, New Delhi and Mata Chanan Devi Hospital, C-1, Janakpuri, New Delhi-110058, resulting in her death on 18.05.2015, was confirmed by the Delhi Medical Council.

The Council further confirmed the punishment of removal of name of Dr. Sudha Kumari (Dr. Sudha Anand, Delhi Medical Council Registration No. 28570) awarded by the Disciplinary Committee for a period of 15 days.

The Council further observed that the Order directing the removal of name from the State Medical Register of Delhi Medical Council shall come into effect after 30 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (g) The Order of the Disciplinary Committee in complaint No. 2509-A representation from Police Station, North Avenue, New Delhi, seeking medical opinion in respect of death of Smt. Veenita, allegedly due to medical negligence on the part of doctors of Dr. RML Hospital, New Delhi in the treatment administered to Smt. Veenita at Dr. RML Hospital, was confirmed by the Delhi Medical Council.
- (h) The Order of the Disciplinary Committee in complaint No. 2299 Shri Hemant Sood, 236, Bannu Enclave, Parwana Road, Pitam Pura, New Delhi-110034, alleging professional misconduct on the part of Dr. Shivi Jaggi, 282, Rajdhani Enclave, Pitampura, New Delhi, was confirmed by the Delhi Medical Council.
- (i) The Order of the Disciplinary Committee in suo motu notice of a prescription dated 14.04.20 of K.S. Nursing Home, Bisrakh Road, Haldoni Greater Noida, (G.B Nagar)-201306, prescription dated 28.05.20 of N.C. Hospital, 53-54, Sewak Park, Dwarka

Mor, Opp. Metro Pillar No.775, New Delhi-110059 (Near Dwarka More Metro Station) and USG whole abdomen report dated 04.05.2020 of J.S. Diagnostic Centre, Near 53-54, Sewak Park, Dwarka Mod, issued by Dr. Gajinder Nayyar in violation of the Delhi Medical Council's Order No.DMC/DC/ F.14/Comp.2491/2/2019/286131, 39, 40, 43-45 dated 30th October, 2019 in complaint no.2491, whereby he was suspended from practicing for the period of 365 days w.e.f. 30th November, 2019, was confirmed by the Delhi Medical Council.

The Council further confirmed the punishment of removal of name of Dr. Gajinder Nayyar (Dr. Gajinder Kumar Nayyar, Delhi Medical Council Registration No. 36809) awarded by the Disciplinary Committee for a period of five years.

The Council further observed that the Order directing the removal of name from the State Medical Register of Delhi Medical Council shall come into effect after 30 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

The Secretary informed that there are no minutes of the Anti Quackery Committee of the Delhi Medical Council on which discussion is required, as no meeting of the Anti Quackery Committee of the Delhi Medical Council had been convened.

The minutes of the meeting of the Finance Committee of the Delhi Medical Council held on 24th June, 2020 and 25th August, 2020, respectively (**appended herewith as annexure 'B', colly**) which were circulated to the members present, were confirmed.

The minutes of the meeting of the Land and Building Committee of the Delhi Medical Council held on 24th June, 2020 and 25th August, 2020, respectively (**appended herewith as annexure 'C', colly**) which were circulated to the members present, were confirmed.

7) Any other item with permission of Chair.

- (a) The Chairman, CME Committee of the Delhi Medical Council Dr. Narendra Kumar Saini presented the report for Webinar Accreditation and Credit Hours. The Council approved the same and directed the office to circulate amongst the Council members through e-mail with a request to give their comments/suggestions/recommendations, within three days, to the office, so that the same can be put before the CME Committee of the Delhi Medical Council for draft the final report for Webinar Accreditation and Credit Hours of online CME's (Continuing Medical Education) and Webinars and awarding Credit Hours for the same.
- (b) The President, Delhi Medical Council briefed the members about request from the Delhi Police to have an MoU between the Delhi Police and the Delhi Medical Council regarding General Allopathic Health Services for Delhi Police personnel and their families through outreach OPD's at designated Delhi Police Wellness Centres located at various police residential colonies in Delhi. Providing all logistics, will be the responsibilities of the Delhi Police. The Delhi Medical Council will provide the allopathic doctors for weekly consultation for two hours to these Wellness Centres. The Delhi Police has agreed to pay Rs.600/- per hour to these doctors. The Council members approved the agreement but honorarium to be incurred to Rs.750/- per hour.
- (c) The application of the individuals who have completed their internship in the year December, 2019 from different Institutes in China, seeking exemption from repeat of Internship Training in India, was taken up for consideration before the Council.

On perusal of the representation and enclosing therewith an Advisory regarding acceptance of internship of Foreign Medical Graduates, issued by Medical Council of India vide letter no- MCI-203(1)(Gen)/2020-Regn./112442 dated 30th July, 2020, wherein the Medical Council of India has adverted to a Public Notice issued by Government of India, Ministry of Health and family Welfare as per which it has been stated that the Internship training completed by an Indian national during his/her MBBS course in China was/is acceptable for the purpose of grant of permanent registration under section 13(3) of the Indian Medical Council Act, 1956. It is not mandatory for such students to do 12 months internship training in India.

The Medical Council of India letter further states that the position stated above is in accordance with provisions of Indian Medical Council Act, 1956 and also identical in respect of MBBS or equivalent "primary medical qualification" obtained by an Indian national from any other country also such as Bangladesh, Nepal, Philippines etc. Therefore, it is advisable that all State Medical Councils while processing application of Foreign Medical Graduates take note of the above stated position.

In light of above, the Council revisited its earlier decision taken in meeting on 21st February, 2020(which mandated repeat internship by Foreign Medical Graduates except Nepal) and decided to rescind the same. The Council, therefore, directed that Foreign Medical Graduates who have applied for permanent registration with the Delhi Medical Council, be considered for the same, based on their medical qualifications and requisite Internship Training Certificate issued by Institutes/Colleges outside India and also having passed the Screening Test; subject to verification of all the necessary documents from the concerned authorities.

The Council further directed that the Hon'ble Union Health Minister and the Medical Council be requested to reconsider its decision regarding acceptance of internship of Foreign Medical Graduates, issued by Medical Council of India vide letter no- MCI-203(1)(Gen)/2020-Regn./112442 dated 30th July, 2020.
