**Minutes of the Council meeting of the Delhi Medical Council held on 27th March, 2019 in
Conference Room of the Delhi Medical Council.**

A meeting of the Delhi Medical Council was convened on 27th March, 2019 for 3.30 pm in Conference Room of the Delhi Medical Council.

Dr. Arun Kumar Gupta welcomed the members to the meeting.

The following agenda was discussed:-

1. To discuss the letter for acceptance from Delhi Metro Rail Corporation Limited (DMRC) with regard to space allotment at DMRC IT Park, Shastri Park.

The Secretary briefed the Council about the allotment letter received from the Delhi Metro Rail Corporation Limited (DMRC) for allotment of space of 1033 square meter for the office of the Delhi Medical Council at Ground Floor, Block-I, DMRC IT Park, Shastri Park, Metro Station, the DMRC has accepted the following three conditions :-

- (a) Lease fee was reduced to Rs.600/- sqm/month (**earlier-Rs.675/- sqm/month**).
- (b) Moratorium period i.e. rent free fit out period shall be six months from the date of handing over of the area (**earlier-three months**).
- (c) Interest free security deposit equivalent to six months recurring lease fee (**earlier-twelve months**).

The Secretary also briefed the Council about the monthly rent payment to DMRC which comes to Rs.9,16,034/-.

The Secretary briefed the Council about the income and expenditure of the Council of previous year.

The Council took a note of the expenditure to be incurred on renovation of the above said built-up space and taking cognizance of the previous year figures of income and expenditure of the Council; decided that rent can be paid from left out income.

The Council unanimously decided that the space may be taken on rent from the DMRC.

2. To discuss cases of medical negligence and unethical conduct.

- (a) The Order of the Executive Committee in complaint No.2520 of Smt. Seema Achall, 42 Crow Hill Lane, Great Cambourne, Cambridgeshire, CB 23 5 AW, forwarded by Directorate General of Health Services, alleging medical

negligence on the part of doctors of Batra Hospital, in the treatment of complainant's mother Smt. Kaushalaya Devi, resulting in her death, was confirmed by the Delhi Medical Council.

- (b) The Order of the Executive Committee in complaint No.2582- a representation from Police Station, Amar Colony, Delhi, seeking medical opinion on a complaint of Shri. Sandeep Roda, r/o- House No. A-21, East of Kailash, New Delhi, alleging medical negligence on the part of doctors of National Heart Institute, 49-50, Community Centre, East of Kailash, New Delhi-110065 in the treatment of complainant's mother Smt. Kamla Roda, resulting in her death on 15.09.2016, was confirmed by the Delhi Medical Council.
- (c) The Order of the Executive Committee in complaint No.2626-Shri Atul Aggarwal, r/o- D.U.-17, Pitampura, Delhi, forwarded by the Medical Council of India, alleging medical negligence on the part of Dr. Palash Gupta of Max Super Specialty Hospital, Shalimar Bagh, Delhi, in the treatment administered to complainant at Max Super Specialty Hospital, was confirmed by the Delhi Medical Council
- Dr. Arun Kumar Gupta recused himself from the proceedings.
- (d) The Order of the Executive Committee in complaint No.2628 of Smt. Swarn Lata, r/o- House No. 78, Gali No. 05, C-Block, Swaroop Vihar, Delhi-110036, alleging medical negligence in examination/preparation of ultra sound report of complainant by Capital Diagnostic Centre, was confirmed by the Delhi Medical Council.
- (e) The Order of the Executive Committee in complaint No.2629 of Shri Vivek Dahiya, r/o- House No.10, Vijay Block, Vipin Garden Ext., Uttam Nagar, Delhi-110054, alleging negligence in examination/preparation of ultra sound report of complainant's father Shri Ramesh Kumar by Dr. Lalita Chaudhary of National Imaging and Path Labs, Plot No. 01, Opp. Metro pillar no.799, Vipin Garden Ext., Dwarka more, Uttam Nagar, New Delhi-110059, was confirmed by the Delhi Medical Council.

- (f) The Order of the Executive Committee in complaint No.2376 of Shri Gurmeet Singh s/o Shri Narinder Singh Saluja r/o 17/11, Third Floor, West Patel Nagar, New Delhi-110008, forwarded by Dy. Commissioner of Police, Central Distt., Delhi alleging medical negligence on the part of Sir Ganga Ram Hospital in the treatment administered to complainant, was confirmed by the Delhi Medical Council.
- (g) The Order of the Executive Committee in complaint No.2600 of Smt. Sumona Majumdar d/o Late Smt. Mamata Majumdar, r/o EPDP CGH Society, Flat-824, Plot No. 19, Sector-4, Dwarka, New Delhi-110075, alleging medical negligence and professional misconduct on the part of doctors of RML Hospital, in the treatment of complainant's mother Late Smt. Mamata Majumdar, resulting in her death on 26.01.2018, was confirmed by the Delhi Medical Council.
- (h) The Order of the Executive Committee in complaint No.2656 of Shri Jagseer Singh, House No. 396, Income Tax Colony, Pitampura, New Delhi, alleging medical negligence in examination/preparation of Ultrasound report of complainant's wife Smt. Sandeep Kaur by Dr. Sarabjeet Narang, Must & More Healthcare Pvt. Ltd, 3rd Floor, Kings Mall, Rohini West Metro Station, Sector-10, Rohini, New Delhi-110085, was confirmed by the Delhi Medical Council.
- (i) The Order of the Executive Committee in complaint No.2652-a representation from Police Station Amar Colony seeking medical opinion on a complaint of Smt. Poonam Kapoor w/o late Shri Vikram Kapoor, r/o A-261, Omaxe Villa, Omaxe City, NH-I, Sonapat, Haryana-131001, alleging medical negligence on the part of doctors of National Heart Institute, in the treatment of complainant's husband Shri Vikram Kapoor, resulting in his death on 14.02.20178, was confirmed by the Delhi Medical Council.
- (j) The Order of the Executive Committee in complaint No.2593 of Shri Prashant Sharma r/o B-19, Yadav Nagar, Samaypur, Delhi-110042, alleging medical negligence on the part of doctors of Ekta Hospital, in the treatment of his new born baby at Ekta Hospital, Yadav Nagar, Samaypur Delhi-110042, resulting in

his death on 1.10.2018 at Jaipur Golden Hospital, Rohini where the baby subsequently received treatment, was confirmed by the Delhi Medical Council.

- (k) The Order of the Executive Committee in complaint No.2687-a representation from Police Station, Narela, Delhi, seeking medical opinion regarding alleged medical negligence on the part of doctors of Reena Janana & Surgical Hospital, Narela, Delhi, in the treatment administered of Smt. Himanshi, was confirmed by the Delhi Medical Council.
- (l) The Order of the Executive Committee in complaint No.2670 of Shri Sunny Kumar, s/o Shri Ashok Kumar r/o G-541, Jahagirpuri, Delhi-110033, alleging medical negligence on the part of Dr. Vijay Manni and Dr. Ashish Gupta of Vinayak Hospital, in the treatment of complainant's mother Smt. Prem Kumari at Vinayak Hospital, was confirmed by the Delhi Medical Council.
- (m) The Order of the Executive Committee in complaint No.2630-a representation from the Police Station Lajpat Nagar, seeking medical opinion on a complaint of Smt. Meenakshi Saini r/o 267, Masjid Moth, Near Udaya Park, New Delhi-110049, alleging medical negligence on the part of Moolchand Khairati Ram Hospital, in the treatment administered to complainant's mother Smt. Premlata, resulting in her death on 24.09.2018, was confirmed by the Delhi Medical Council.
- (n) The Order of the Executive Committee in complaint No.2606 of Shri Ashwani Kumar, Garhwal Trust House, 27, Rani Jhansi Road, New Delhi-110055, alleging medical negligence on the part of Dr. Monisha Kapoor, J-18, Near SBI Bank, Mahrauli Badarpur Road, Saket, Delhi-110017, in the treatment of complainant, was confirmed by the Delhi Medical Council.
- (o) The Order of the Disciplinary Committee in complaint No.2353 of Shri Karambir r/o village Ridhau, Post Office Farmana, Distt. Sonapat, Haryana, forwarded by Public Grievance Monitoring System alleging medical negligence on the part of doctors of Jaipur Golden Hospital, Sector-03, Rohini, Delhi-110085, in the

treatment administered to complainant's son Master Vashu at Jaipur Golden Hospital, was taken up for confirmation before the Delhi Medical Council.

The Council observed that the matter be referred back to the Disciplinary Committee for re-consideration on the following issues :-

- (i) The patient was given Midazolam 0.2 mg diluted in 5 ml at 10.00 a.m. (17-01-2018). Dr. Abha Aggarwal and senior resident Dr. Roshan Kumar went to O.T. at 10.10 a.m. As per modified aldrete scores everything (all parameters) were normal at every five minute interval till 10.30 a.m. Modified aldrete scoring is needed to be done at ten minutes interval. As per records, the patient was found to have cardiac arrest at 10.35 a.m. when consultants reached to resuscitate the patient. Was proper monitoring done between 10.10 a.m. -10.30 a.m. by a qualified health care professional?

Once the aforementioned issues are determined by the Disciplinary Committee, the matter be placed before the Council for consideration/confirmation.

- (p) The Order of the Disciplinary Committee in complaint No.2213-a representation No.F7/2/DCW/RCC/2017/896 dated 11.09.2017 from Chairperson, Delhi Commission for Women, seeking action against doctors of All India Institute of Medical Sciences for alleged professional misconduct in respect of MLC of baby 'X', was confirmed by the Delhi Medical Council.

The Council also confirmed the punishment of warning awarded to Dr. Varnit (Delhi Medical Council Registration No.40814) by the Disciplinary Committee.

- (q) The Order of the Disciplinary Committee in complaint No.2143-a representation from Directorate General Health Services Govt. of NCT of Delhi, seeking investigation into complaint of Shri P.R Sharma r/o 253, Sector- 5 Pushp Vihar, New Delhi-110017, against doctors of Max Smart Super Speciality City Hospital, Saket, was confirmed by the Delhi Medical Council.
- (r) The Order of the Disciplinary Committee in complaint No.1873 of Smt. Rina Kumar w/o Late Ramjyoti Prasad r/o- Akashwani Colony, Aadampur, Bhagalpur,

Bihar-812001, alleging medical negligence on the part of Dr. Anil Prasad Bhatt, Dr. Akhil Mishra and Indraprastha Apollo Hospital, Sarita Vihar, Mathura Road, New Delhi-110076 in the treatment administered to complainant's husband Shri Ramjyoti Prasad at Indraprastha Apollo Hospital, resulting in his death on 25.11.2014, was confirmed by the Delhi Medical Council.

- (s) The Order of the Disciplinary Committee in complaint No.1943 of Mohd. Anwar Ahmed s/o Shri Mukhtar Ahmed, r/o- 5089, Gali No.1, Kokasi, Old Seelam Pur Delhi-110031, alleging medical negligence on the part of doctors of Samra Hospital in the treatment administered to the complainant at Samra Hospital C-4/70-A, Yamuna Vihar, Delhi-110053, was confirmed by the Delhi Medical Council.

The Council also confirmed the punishment of removal of name awarded to Dr. Abdul Khalique (Delhi Medical Council Registration No.16900) by the Disciplinary Committee.

The Council further observed that the Order directing the removal of name from the State Medical Register of Delhi Medical Council shall come into effect after 30 days from the date of the Order.

The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (t) The Order of the Disciplinary Committee in complaint No.1654- a representation from Police Station, Lajpat Nagar, New Delhi, seeking enquiry into a complaint of Shri Pankaj Kumar Singh, alleging medical negligence on the part of doctors of Moolchand Kharati Ram Hospital, in the treatment administered to the complainant's wife Smt. Shabnam Singh, resulting in her death at Moolchand Kharati Ram Hospital, Lajpat Nagar-III, New Delhi, was taken up for confirmation before the Delhi Medical Council.

Whilst confirming the Order of the Disciplinary Committee, the Council observed that since in this case there was failure to exercise due diligence in monitoring the condition of the patient and poor record keeping, interest of

justice will be served, if punishment of suspension of Registration No.13940 of Dr. Sheila Mehra from the State Medical Register of the Delhi Medical Council for period of 30 days is awarded, as Dr. Sheila Mehra was the treating consultant, hence, the name of Sheila Mehra (Delhi Medical Council Registration No.13940) be removed from the State Medical Register of the Delhi Medical Council for a period of 30 days.

The Council further observed that the Order directing the removal of name from the State Medical Register of Delhi Medical Council shall come into effect after 30 days from the date of the Order.

The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (u) The Order of the Disciplinary Committee in complaint No.2465 of Smt. Mahima Arora, w/o Shri Sunny Arora, r/o- 2677, Outram Lane, Kingsway Camp, Delhi-110009, forwarded by the Medical Council of India, alleging medical negligence on the part of doctors of Jivodaya Hospital, Ashok Vihar, Phase-1, Delhi-110052, was confirmed by the Delhi Medical Council.
- (v) The Order of the Disciplinary Committee in complaint No.2637- a reference from Medical Council of India seeking investigation into a representation from Shri Hardeep S Puri Hon'ble Minister of State (I/C) Housing and Urban Affairs Govt. of India into alleged medical negligence in the treatment administered to 9yrs old baby Madiha at Khadija National Hospital, was confirmed by the Delhi Medical Council.
- (w) The Order of the Disciplinary Committee in complaint No.1694 of Smt. Kanan Shree Thareja r/o, Shree Ganesh Appartments, C-801, Plot No.12-B, Sector-7, Dwarka, New Delhi-110075, alleging medical negligence on the part of Dr. Saurabh Moda, Talwar Medical Centre, M-139, G.K.-II, New Delhi-110048, in the treatment administered to the complainant at Talwar Medical Centre, was taken up for confirmation before the Delhi Medical Council.

Whilst confirming the Order of the Disciplinary Committee, the Council observed that since Dr. Saurabh Moda made an error in judgment by making a wrong diagnosis, but as a result of same, there was no consequential damage to the patient, hence, the punishment of removal of name awarded to Dr. Surabh Moda (Delhi Medical Council Registration No.15823) by the Disciplinary Committee from the State Medical Register of the Delhi Medical Council for a period of 180 days is not warranted. However, since Dr. Saurabh Moda has been misrepresenting his qualifications; his (Dr. Saurabh Moda) name (Delhi Medical Council Registration No.15823) be removed from the State Medical Register of the Delhi Medical Council for a period of 30 days with a direction that he should undergo 12 hours of C.M.E. (Continuing Medical Education) on the subject 'Peripheral Vascular Disease' within a period of six months and submit a compliance report to this effect to the Delhi Medical Council

The Council further observed that the Order directing the removal of name from the State Medical Register of Delhi Medical Council shall come into effect after 30 days from the date of the Order.

The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (x) The Order of the Disciplinary Committee in complaint No.2003 of Shri Ved Prakash, r/o- D-578, Avantika, Sector -1, Rohini, Delhi-110085, forwarded by the Medical Council of India, alleging negligence on the part Dr. Nisha of M/S National MRI CT Scan & Diagnostic Centre (A unit of Shree Hari Diagnostic Pvt. Ltd.) 19/23, Main Rohtak Road, West Punjabi Bagh, Near Maharaja Agrasen Hospital, New Delhi-110002, in the preparation of radiology report of the complainant, was confirmed by the Delhi Medical Council.

The Council also confirmed the punishment of warning awarded Dr. Nisha (Dr. Nisha Rani, Delhi Medical Council Registration No.DMC/R/2461) and Dr. N.K. Sharma (Dr. Nand Kishore Sharma, Delhi Medical Council Registration No.25645) by the Disciplinary Committee.
