

2. Action taken report of minutes of the meeting held on 9th May, 2019.

3. To discuss cases of medical negligence and unethical conduct.

- (a) The Order of the Executive Committee in complaint No.2753- a representation from Police, seeking opinion on a complaint of Shri Kuwar Pal Singh r/o K-4763, Dakshinpuri, Amedkar Nagar, New Delhi alleging medical negligence in the treatment of Shri Sumit Kumar at Max Hospital, Saket, New Delhi, was confirmed by the Delhi Medical Council.
- (b) The Order of the Executive Committee in complaint No.2607-a representation from police station Saket, seeking medical opinion on a complaint Shri Ankit Shrivastav alleging medical negligence on the part of doctors of Max Hospital Saket, New Delhi in the treatment of complainant, was confirmed by the Delhi Medical Council.
- (c) The Order of the Executive Committee in complaint No.2584 of Shri Kuldeep Singh, s/o Shri. Ramji Lal r/o- Rukali Tehsil Bilaspur Dist., Yamuna Nagar, Haryana, forwarded by the Medical Council of India, alleging medical negligence on the part of doctors of All Chemist Hospital, Chandigarh and Institute of Institute of Liver and Biliary Sciences, D-1, Vasant Kunj, New Delhi, in the treatment administered to complainant's son Shri. Amit Rathi, resulting in his death, was confirmed by the Delhi Medical Council

- (d) The Order of the Executive Committee in complaint No.2668 of Shri Mohan Chander Joshi, 400, Type 4, Sector-04, R.K Puram, New Delhi-110022, forwarded by the Medical Council of India, alleging medical negligence on the part of doctors All India Institute of Medical Sciences, Ansari Nagar, New Delhi-110029, in the treatment administered to complainant's wife Smt. Hema Mohan Joshi, resulting in her death, was confirmed by the Delhi Medical Council.
- (e) The Order of the Executive Committee in complaint No.2735-a representation from Police station Dwarka South, seeking medical opinion in respect of death of Smt. Radha T. Nair, allegedly due to medical negligence in the treatment administered to Smt. Radha T. Nair at Manipal Hospital, Human Care Medical Charitable Trust, adjoining MTNL Building, Sector-6, Dwarka, New Delhi-110075, resulting in her death, was confirmed by the Delhi Medical Council.
- (f) The Order of the Executive Committee in complaint No.2791- a representation from Police Station Anand Vihar, seeking medical opinion on a complaint of Smt. Tina Vohra c/o Mr. Deepak K. Sehgal r/o A-47, Shivaji Vihar, New Delhi, alleging professional misconduct on the part of Dr. Anil Kumar Jain of Jain Neuro Centre, 177-178, Jagriti Enclave, Vikas Marg Extn. Delhi, in the treatment of complainant, was confirmed by the Delhi Medical Council.
- (g) The Order of the Executive Committee in complaint No.2726- Mohd. Mohsin, r/o- 1696, Gali Takhti Wali, Sui Walan, Daryaganj, Delhi-110002, alleging negligence in the preparation/examination of Transthoracic Echo-Doppler report of complainant's son Mohd. Arhan by Dr. M.K. Gupta and Dr. Avinash, Focus Imaging and Research Centre, Pvt. Ltd., C-10, H-10, Green Park Extension, New Delhi-110016, was taken up for consideration before the Delhi Medical Council.

The Order of the Executive Committee was taken up for consideration, the Council was of the view that in the facts and circumstances of this case, the doctors needs to be called for hearing before the Disciplinary Committee of the Delhi Medical Council, hence, the matter be referred for hearing before the Disciplinary Committee of the Delhi Medical Council.

- (h) The Order of the Executive Committee in complaint No.2521 of Smt. Reshma r/o T-330 Begam Pur, Malviya Nagar, New Delhi-110017, alleging medical negligence in the preparation/examination of pathology report of the complainant, was confirmed by the Delhi Medical Council.
- (i) The Order of the Disciplinary Committee in complaint No.2716-a suo motu notice, of medical certificate issued dated 18.02.2016, 06.06.2016, 08.12.2016, 27.12.2016 and 30.04.2017 by Dr. Mahesh Chand Jain to Shri Sanjeev Thomas, as the same prima facie does not appear to be in conformity with Indian Medical Council (Professional Conduct, Etiquette and Ethics), Regulations, 2002 and the guidelines for issuance of medical certificate framed by Delhi Medical Council, was confirmed by the Delhi Medical Council.
- (j) The Order of the Disciplinary Committee in complaint No.1925 of Shri Obua Patric, r/o- Apac town, Apac, Uganda East Africa, alleging medical negligence on the part of doctors of Dr. Feroz Pasha and Apollo Hospital, Sarita Vihar, Delhi-Mathura Road, New Delhi-110076 in the treatment administered to the complainant's mother late Smt. Janet Auma at Apollo Hospital, resulting in her death on 17.08.2016, was taken up for confirmation before the Delhi Medical Council.

Whilst confirming the Order of the Disciplinary Committee, the Council observed that since in the facts and circumstances of this case, the surgery was not absolutely contraindicated and it was done after taking consent, but had unfavourable outcome; no punishment is warranted against Dr. Feroz Pasha.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (k) The Order of the Disciplinary Committee in complaint No.2194 of Shri Brij Nand., D-62, Gali No.4, Johripur Extension, Delhi-110094, alleging medical negligence on the part of doctors of J P Hospital, A 1/7 A, Main Wazirabad Road, Bhajanpura, Near Khajuri Chowk, Delhi-110053, in the treatment

administered to complainant's wife Smt. Rekha, was confirmed by the Delhi Medical Council.

- (l) The Order of the Disciplinary Committee in complaint No.2277- a representation form Police Station, Dwarka, North, seeking medical opinion in respect of death of Smt. Madhu allegedly due to medical negligence in the treatment administered to late Smt Madhu at Life Line Hospital, 42, Sector-12B, Dwarka, New Delhi-110075, was confirmed by the Delhi Medical Council.
- (m) The Order of the Disciplinary Committee in complaint No.1810 of Shri Mrityunjay Kumar r/o- A 002 MTNL Staff Quarter Apartment Pocket, B-4, Rohini, Sector 03, Delhi-110085, alleging medical negligence on the part of Dr. Nisha Jain, Dr. Renu Gupta and Saroj Super Specialty Hospital, in the treatment administered to Smt. Pooja Rai at Saroj Super Specialty Hospital, Madhuban Chowk, Rohini, Delhi-110085, resulting in her death on 01.09.2015, was confirmed by the Delhi Medical Council.
- (n) The Order of the Disciplinary Committee in complaint No.1964 of Shri Ajay Kumar Dubey, Addl. Legal Advisor, Central Bureau of Investigation, CBI Headquarters, 5-B, CGO Complex, Lodhi Road, New Delhi-110003, forwarded by the Medical Council of India, alleging medical negligence on the part of Dr. Paras Gangwal, DDA Flat No.17 RPS, Mansarovar Park, Shahdara, Delhi-110032 in the treatment administered to complainant's wife Smt.Usha Rani, resulting in her death, was confirmed by the Delhi Medical Council.
- (o) The Order of the Disciplinary Committee in complaint No.1744 of Shri Naeem Khan, r/o- A-5/38 A DDA Flats, Inder Lok, New Delhi, alleging medical negligence on the part of Dr. V.S. Malik, Malik Hospital, 6, Avtar Enclave, Rohtak Road, New Delhi-110063, in the treatment administered to the complainant's sister Smt. Surraiya at Malik Hospital, was confirmed by the Delhi Medical Council.
- (p) The Order of the Disciplinary Committee in complaint No.1672 of Miss. Kiran, r/o- B-329, A.V. Nagar, All India Institute of Medical Sciences Campus, New

Delhi-110049, alleging medical negligence on the part of doctors of All India Institute of Medical Sciences, Ansari Nagar, New Delhi-110029, in the treatment administered to the complainant's brother Shri Bharat Agria, resulting in his death on 31st August, 2015, was taken up for confirmation before the Delhi Medical Council.

Whilst confirming the Order of the Disciplinary Committee, the Council noted that there was a factual error in the sequence of event, reflected in summary of this case, recorded in point (1) of the observations of the Disciplinary Committee's Order, as it has been incorrectly mentioned that the patient was discharged at 12.25 p.m. (30.05.2015); since as per the medical records of the said Hospital and the complainant's version, the patient was probably discharged at around 7.00 a.m. (30.08.2015) when he had earlier reported in emergency at 6.10 a.m./6.30 a.m. on 30th August, 2015. It is, thus, directed that following modification/correction be made in the of the Order of the Disciplinary Committee.

"At 7.00 a.m., the blood-pressure was recorded as 124/76 mmHg and noted to be stable, thus, discharged at 12.25 p.m. (30-05-2015) with advise to follow-up in OPD on medication tablet pan D 40 mg, tablet emset and tablet tramadole. The blood pressure was not recorded again at the time of discharge at 12.25 p.m. The patient reported to All India Institute of Medical Sciences at 1.30 p.m. again on 30th August, 2015, when he was examined by Dr. Avneesh Asthana Junior Resident (non-academic); the blood-pressure was noted as NR (not recordable)."

be substituted with :-

"At 7.00 a.m., the blood-pressure was recorded as 124/76 mmHg and noted to be stable, fit to be discharged on medication Tablet Pan 40, Tablet Emset and for OPD follow-up. The patient, thereafter, reported to emergency of All India Institute of Medical Sciences at 12.25 p.m. (30.08.2015) when he was prescribed tablet Tramadole and syrup Loose. The blood-pressure was not recorded at 12.25 p.m. (30.08.2015). The patient at 1.30 p.m. (30.08.2015), was examined by

Dr. Avnesh Asthana, Junior Resident (non-academic); the blood pressure was noted as NR (not recordable)".

The matter was deliberated in detail but could not be concluded.

1. **Shri Ashok Kumar Chaudhary:-** Shri Ashok Kumar Chaudhary neither replied nor appear before the Anti-Quackery Committee in response to Show Cause Notice No.DMC/AQ/F.3-A/SCNs/2/2019/282879 dated 18th June, 2019. The Anti-Quackery Committee noted that notice sent to Shri Ashok Kumar Chaudhary returned undelivered in the office of Delhi Medical Council with noting from the Postal Department "refused". On examination of the inspection report no. F.6/29/2019/DHS/Estt/NED/AQ/2384-85 dated 26th February, 2019 received from the office of the CDMO (North East District), in respect of Shri Ashok Kumar Chaudhary the Anti Quackery Committee noted that Shri Ashok Kumar Chaudhary has been practicing allopathy without holding any requisite medical qualification as enumerated in the Schedules I, II, III of the Indian Medical Council Act 1956, entitling him to practice in allopathy and also not being registered with the Delhi Medical Council, in violation of the Section 15(6) of the Delhi Medical Council Act, 1997.

In light of the above, the Anti Quackery Committee, hereby, in exercise of powers conferred under section 10(h) of the Delhi Medical Council, Act, 1997 recommends that Shri Ashok Kumar Chaudhary be directed to stop practicing allopathy, forthwith, and to close down his clinic and Anti Quackery Committee also decided that the police be requested to register a FIR under Section 27 of Delhi Medical Council Act, 1997 alongwith relevant Section of IPC.

2. **Shri Gopal:-** Shri Gopal neither replied nor appeared before the Anti-Quackery Committee in response to Show Cause Notice No.DMC/AQ/F.3-A/SCNs/2/2019/282983 dated 18th June, 2019. On examination of the inspection report no. No.F.1/17/(Part XXVII)/2001/DHS/NWD/AQ/7086 dated 27th March, 2019 received from the office of the CDMO (North West District), in respect of Shri Gopal the Anti Quackery Committee noted that Shri Gopal has been practicing allopathy without holding any requisite medical qualification as enumerated in the Schedules I, II, III of the Indian Medical Council Act 1956, entitling him to practice in allopathy and also not being registered with the Delhi Medical Council, in violation of the Section 15(6) of the Delhi Medical Council Act, 1997.

In light of the above, the Anti Quackery Committee, hereby, in exercise of powers conferred under section 10(h) of the Delhi Medical Council, Act, 1997 recommends that Shri Gopal be directed to stop practicing allopathy, forthwith, and to close down his clinic and Anti Quackery Committee also decided that the police be requested to register a FIR under Section 27 of Delhi Medical Council Act, 1997 alongwith relevant Section of IPC.

3. **Shri Anup Kumar Roy:-** Shri Anup Kumar Roy neither replied nor appeared before the Anti-Quackery Committee in response to Show Cause Notice No.DMC/AQ/F.3-A/SCNs/2/2019/282984 dated 18th June, 2019. On examination of the inspection report no. No.F.1/17/(Part XXVIII)/2001/DHS//NWD/AQ/7051-53 dated 20th March, 2019 received from the office of the CDMO (North West District), in respect of Shri Anup Kumar Roy the Anti Quackery Committee noted that Shri Anup Kumar Roy has been practicing allopathy without holding any requisite medical qualification as enumerated in the Schedules I, II, III of the Indian Medical Council Act 1956, entitling him to practice in allopathy and also not being registered with the Delhi Medical Council, in violation of the Section 15(6) of the Delhi Medical Council Act, 1997.

In light of the above, the Anti Quackery Committee, hereby, in exercise of powers conferred under section 10(h) of the Delhi Medical Council, Act, 1997 recommends that Shri Anup Kumar Roy be directed to stop practicing allopathy, forthwith, and to close down his clinic and Anti Quackery Committee also decided that the police be requested to register a FIR under Section 27 of Delhi Medical Council Act, 1997 alongwith relevant Section of IPC.

4. **Shri Sumit Sharma:-** Shri Sumit Sharma neither replied nor appeared before the Anti-Quackery Committee in response to Show Cause Notice No.DMC/AQ/F.3-A/SCNs/2/2019/282985 dated 18th June, 2019. On examination of the inspection report no. F.6/29/2019/DHS/Estt/NED/AQ/217 dated 23rd April, 2019 received from the office of the CDMO (North East District), in respect of Shri Sumit Sharma the Anti Quackery Committee noted that Shri Sumit Sharma has been practicing allopathy without holding any requisite medical qualification as enumerated in the Schedules I, II, III of the Indian Medical Council Act 1956, entitling him to practice in allopathy and also not being registered with the Delhi Medical Council, in violation of the Section 15(6) of the Delhi Medical Council Act, 1997.

In light of the above, the Anti Quackery Committee, hereby, in exercise of powers conferred under section 10(h) of the Delhi Medical Council, Act, 1997 recommends that Shri Sumit Sharma be directed to stop practicing allopathy, forthwith, and to close down his clinic and Anti Quackery Committee also decided that the police be requested to register a FIR under Section 27 of Delhi Medical Council Act, 1997 alongwith relevant Section of IPC.

5. **Shri Pradeep Kumar:-** Shri Pradeep Kumar appeared before the Anti-Quackery Committee and submitted a reply. The reply submitted by Shri Pradeep Kumar was found to be unsatisfactory in response to Show Cause Notice No.DMC/AQ/F.3-A/SCNs/2/2019/282986 dated 18th June, 2019. On examination of the inspection report no. File No: 1/30/2018/DHS/Anti Quack/ED/20 dated 03rd April, 2019 received from the office of the CDMO(East District), in respect of Shri Pradeep Kumar the Anti Quackery Committee noted that Shri Pradeep Kumar has been practicing allopathy without holding any requisite medical qualification as enumerated in the Schedules I, II, III of the Indian Medical Council Act 1956, entitling him to practice in allopathy and also not being registered with the Delhi Medical Council, in violation of the Section 15(6) of the Delhi Medical Council Act, 1997.

In light of the above, the Anti Quackery Committee, hereby, in exercise of powers conferred under section 10(h) of the Delhi Medical Council, Act, 1997 recommends that Shri Pradeep Kumar be directed to stop practicing allopathy, forthwith, and to close down his clinic and Anti Quackery Committee also decided that the police be requested to register a FIR under Section 27 of Delhi Medical Council Act, 1997 alongwith relevant Section of IPC.

6. **Shri Omkar Dutt Bhardwaj:-** Shri Omkar Dutt Bhardwaj neither replied nor appeared before the Anti-Quackery Committee in response to Show Cause Notice No.DMC/AQ/F.3-A/SCNs/2/2019/282987 dated 18th June, 2019. The Anti Quackery Committee noted that notice sent to Shri Omkar Dutt Bhardwaj returned undelivered in the office of Delhi Medical Council with noting from the Postal Department "No Such Person".

In the light of the above the Anti-Quackery Committee directed that the concerned Chief District Medical Officer (East District) be asked to provide complete and correct address of Shri Omkar Dutt Bhardwaj to the office of the Delhi Medical Council. Once the same is received, show cause notice again be issued to Shri Omkar Dutt Bhardwaj.

7. **Shri Imran:-** Shri Imran neither replied nor appeared before the Anti-Quackery Committee in response to Show Cause Notice No.DMC/AQ/F.3-A/SCNs/2/2019/282988 dated 18th June, 2019. The Anti Quackery Committee noted that notice sent to Shri Imran returned undelivered in the office of Delhi Medical Council with noting from the Postal Department "Incomplete Address".

In the light of the above the Anti-Quackery Committee directed that the concerned Chief District Medical Officer (East District) be asked to provide complete and correct address of Shri Imran to the office of the Delhi Medical Council. Once the same is received, show cause notice again be issued to Shri Imran.

8. **Shri Mumtaz Ali:-** Shri Mumtaz Ali neither replied nor appeared before the Anti-Quackery Committee in response to Show Cause Notice No.DMC/AQ/F.3-A/SCNs/2/2019/282989 dated 18th June, 2019. The Anti Quackery Committee noted that notice sent to Shri Mumtaz Ali returned undelivered in the office of Delhi Medical Council with noting from the Postal Department "Incomplete Address".

In the light of the above the Anti-Quackery Committee directed that the concerned Chief District Medical Officer (East District) be asked to provide complete and correct address of Shri Mumtaz Ali to the office of the Delhi Medical Council. Once the same is received, show cause notice again be issued to Shri Mumtaz Ali.

9. **Shri Zubair Alam Alias Arshad:-** Shri Zubair Alam Alias Arshad neither replied nor appeared before the Anti-Quackery Committee in response to Show Cause Notice No.DMC/AQ/F.3-A/SCNs/2/2019/282990 dated 18th June, 2019. The Anti Quackery Committee noted that notice sent to Shri Zubair Alam Alias Arshad returned undelivered in the office of Delhi Medical Council with noting from the Postal Department "Incomplete Address".

In the light of the above the Anti-Quackery Committee directed that the concerned Chief District Medical Officer (East District) be asked to provide complete and correct address of Shri Zubair Alam Alias Arshad to the office of the Delhi Medical Council. Once the same is received, show cause notice again be issued to Shri Zubair Alam Alias Arshad.

10. **Shri Zeesan Khan:-** Shri Zeesan Khan neither replied nor appeared before the Anti-Quackery Committee in response to Show Cause Notice No.DMC/AQ/F.3-A/SCNs/2/2019/282991 dated 18th June, 2019. On examination of the inspection report no. F.3/11/2015/AQIII/SHD/3168 dated 24th May, 2019 received from the office of the CDMO(Shahdara District), in respect of Shri Zeesan Khan the Anti Quackery Committee noted that Shri Zeesan Khan has been practicing allopathy without holding any requisite medical qualification as enumerated in the Schedules I, II, III of the Indian Medical Council Act 1956, entitling him to practice in allopathy and also not being registered with the Delhi Medical Council, in violation of the Section 15(6) of the Delhi Medical Council Act, 1997.

In light of the above, the Anti Quackery Committee, hereby, in exercise of powers conferred under section 10(h) of the Delhi Medical Council, Act, 1997 recommends that Shri Zeesan Khan be directed to stop practicing allopathy, forthwith, and to close down his clinic and Anti Quackery Committee also decided that the police be requested to register a FIR under Section 27 of Delhi Medical Council Act, 1997 alongwith relevant Section of IPC.

11. **Shri Atul Kumar Malakar:-** Shri Atul Kumar Malakar neither replied nor appeared before the Anti-Quackery Committee in response to Show Cause Notice No.DMC/AQ/F.3-A/SCNs/2/2019/282992 dated 18th June, 2019. On examination of the inspection report no. No.F.1(14)2014/CDMO/SE/Estt/1588 dated 07th June, 2019 received from the office of the CDMO(South East District), in respect of Shri Atul Kumar Malakar the Anti Quackery

Committee noted that Shri Atul Kumar Malakar has been practicing allopathy without holding any requisite medical qualification as enumerated in the Schedules I, II, III of the Indian Medical Council Act 1956, entitling him to practice in allopathy and also not being registered with the Delhi Medical Council, in violation of the Section 15(6) of the Delhi Medical Council Act, 1997.

In light of the above, the Anti Quackery Committee, hereby, in exercise of powers conferred under section 10(h) of the Delhi Medical Council, Act, 1997 recommends that Shri Atul Kumar Malakar be directed to stop practicing allopathy, forthwith, and to close down his clinic and Anti Quackery Committee also decided that the police be requested to register a FIR under Section 27 of Delhi Medical Council Act, 1997 alongwith relevant Section of IPC.

12. **Shri Dayachand:-** Shri Dayachand neither replied nor appeared before the Anti-Quackery Committee in response to Show Cause Notice No.DMC/AQ/F.3-A/SCNs/2/2019/282993 dated 18th June, 2019. The Anti Quackery Committee noted that notice sent to Shri Dayachand returned undelivered in the office of Delhi Medical Council with noting from the Postal Department "No Such Person".

In the light of the above the Anti-Quackery Committee directed that the concerned Chief District Medical Officer (East District) be asked to provide complete and correct address of Shri Dayachand to the office of the Delhi Medical Council. Once the same is received, show cause notice again be issued to Shri Dayachand.


13. **Shri Varun Vishwas:-** A representation of PS Nangloi in respect of Shri Varun Vishwas was taken of consideration, the anti-Quackery Committee noted a Show cause issue to Shri Varun Vishwas with direction to stop practicing allopathy (modern scientific system of medicine) forthwith and to appear in Room 308A, 3rd Floor, Administrative Block, Maulana Azad Medical College, Bahadur Shah Zafar Marg, New Delhi – 110002 alongwith your Photo Identification Card, recent photograph and other supportive documents in your defence on 27th June, 2019 (Thursday) at 03:00 PM.


It is noted that Shri Varun Vishwas neither replied nor appeared before the Anti-Quackery Committee in response to Show Cause Notice no. DMC/AQ/F.3-A/SCNs/2/2019/282984 dated 18th June 2019. On, perusal of the representation of Police and documents submitted,

therewith, it is informed that in terms of Section 15(3) read with Section 15(6) of the Delhi Medical Council, Act 1997, only person who possess recognised medical qualification as per Schedule First, Second or Third to the Indian Medical Council, Act 1956, and registered with Delhi Medical Council, as per the Delhi Medical Council, Act 1997, is entitled to practice modern scientific system of medicine (allopathy) in the NCT of Delhi.

The anti quackery committee further noted that hence, Shri Varun Vishwas is not registered with Delhi Medical Council and not entitled to practicing modern scientific system of medicine (allopathy) in the NCT of Delhi.

The anti quackery committee also noted that the list of medicines provided by the police are allopathy drugs, hence, in view of the above the Anti Quackery Committee hereby, in exercise of powers conferred under section 10(h) of the Delhi Medical Council, Act 1997, recommends that Shri Varun Vishwas to be directed to stop practicing allopathy, forthwith and to close down his clinic, Anti Quackery Committee also decided that the police be requested to take action against him under Section 27, of Delhi Medical Council, Act 1997, alongwith relevant Section of IPC.
