A meeting of the Delhi Medical Council was convened 06th November, 2023 for 2.30 p.m. in Conference Room, Ground Floor, B-Wing, Block-1, DMRC IT Park, Shastri Park, New Delhi-110053.

The meeting was adjourned at 2.30 p.m. due to lack of quorum. The meeting was reconvened at 3.00 p.m.

2. Action taken report of minutes of the meeting held 20th September, 2023.

3. To discuss cases of medical negligence and unethical conduct.

- (i) The Order of the Executive Committee in Complaint No. 3181 of Ms. Qaiser Jahan, w/o Mohd. Iqbal, r/o- 3056, Kucha Pandit, Lal Kuan, Ajmeri Gate, Delhi-110006, alleging medical negligence on the part of the doctors of Max Hospital, Saket (East Block), New Delhi-110017, in the treatment administered to the complainant, was confirmed by the Delhi Medical Council.
- (ii) The Order of the Executive Committee in complaint No.3266- of Shri Santosh Kumar, r/o H.No.531, Plot No.-08, Sector-23, Dwarka, Delhi-110077, forwarded by the Directorate General of Health Services, Govt. of NCT of Delhi, alleging medical negligence on the part of the doctors of Sir Ganga Ram Hospital, Old Rajinder Nagar, New Delhi-110060, in the treatment administered to the complainant's father late Ram Narayan Singh at Sir Ganga Ram Hospital, resulting in his death on 18.08.2020, was confirmed by the Delhi Medical Council.

- (iii) The Order of the Executive Committee in complaint No.3730-a representation from Police Station Safdarjung Enclave seeking medical opinion on a complaint of Smt. Savita Bhandari r/o 66C, pocket-C, Mayur Vihar, Phase-2, East Delhi, Delhi-110091, alleging medical negligence on the part of Dr. Gaurav of Safdarjung Hospital, in the treatment of complainant's son Shri Aman Bhandari, resulting in his death on 16.09.2022, was confirmed by the Delhi Medical Council.
- (iv) The Order of the Executive Committee in complaint No.3386 of Shri Tarun Vaid r/o SCO-72, Basement, Swastik Vihar, Delhi forwarded by Dy. Commissioner of Police West District, Delhi, alleging negligence on the part of Dr. Prashant Purwar of Apollo Clinic, C-70, Major Sudesh Kumar Marg, Opp. Madhav Park, Near Main Market, Rajouri Garden, New Delhi-110027, in the preparation/conduct of lab report of the complainant, was confirmed by the Delhi Medical Council.
- (v) The Order of the Executive Committee in complaint No.3696 of Smt. Asha Verma r/o 132, J Extension Street No. 3, Guru Ram Das Nagar, Laxmi Nagar, Delhi-110092, forwarded by National Medical Commission, alleging medical negligence on the part of Dr. Kapil Aggarwal of Arogya Hospital, 32, Vikas Marg, Chitra Vihar, Swasthya Vihar, New Delhi-110092, in the treatment of complainant's son Shri Ritik Verma, was confirmed by the Delhi Medical Council.
- (vi) The Order of the Executive Committee in complaint No.3311 of Sarvodaya Hospital and Research Centre, Sector 8, Faridabad, alleging professional misconduct on the part of Dr. Riya Kumari, House No. 979, Sector 09, Near Anghony School, Haryana-121006, was confirmed by the Delhi Medical Council.
- (vii) The Order of the Executive Committee in complaint No.3763 of Shri Surender w/o Shri Bhojaram, r/o 16/412, I Bapa Nagar, Gali no. 5, Old Chungi Karol Bagh, New Delhi-110005, alleging medical negligence on the part of Dr. Chanchal of Aruna Asaf Ali Govt. Hospital 5, Rajpur Road, Delhi-110054, in the treatment of complainant, was confirmed by the Delhi Medical Council.
- (viii) The Order of the Executive Committee in complaint No.3754 of Shri Sumit Sharma, r/o 299, Tilak Khand, Giri Nagar, Kalkaji, New Delhi-110019, alleging medical negligence on the part of Dr. Pankaj Gupta of RG Stone Urology & Laparoscopy Hospital, in the treatment of complainant's son Mr. Yash Pandit, was confirmed by the Delhi Medical Council.

- (ix) The Order of the Disciplinary Committee in complaint No.2527-a matter relating to Dr. Shiv Shankar Shahi (DMC registration no: 15015), Shahi Clinic, T.C. 239, Raghbir Nagar, Near Central School, New Delhi-110027, associating in connection with his professional practice with one Shri Bam Bahadur Shahi, who is an unqualified medical person in flagrant violation of the Regulation 1.6 of Indian Medical Council (Professional Conduct, Etiquette and Ethics) Regulation, 2002, was confirmed by the Delhi Medical Council.
- (x) The Order of the Disciplinary Committee in complaint No.3253- a representation from Police Station GTB Enclave, Shahdara District, Delhi, alleging professional misconduct on the part of Dr. Barun, in respect of preparation of MLC at Indira Gandhi E.S.I.C. Hospital, Jhilmil, Delhi-110095, in reference to a patient named Smt. Anuradha w/o Ratan Mishra r/o C-3/268, Nand Nagri, Delhi, was taken up for confirmation before the Delhi Medical Council.

Whilst confirming the Order of the Disciplinary Committee, the Council observed that in facts and circumstances of this, the punishment of warning awarded by the Disciplinary Committee to Dr. Anshu Tandon (Delhi Medical Council Registration No.64530), is not warranted, as the patient was treated by Dr. Anshu Tandon as per accepted professional practices in such case.

The Council further confirmed the punishment of warning awarded by the Disciplinary Committee to Dr. Barun Kumar (Delhi Medical Council Registration No.24840).

The Council further observed that the Order directing the issuance of warning shall come into effect after 60 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (xi) The Order of the Disciplinary Committee in complaint No.2772 of Shri Anil Kumar, r/o- Qtr. NLo. 25, Type-II, Sector-III, Sadiq Nagar, New Delhi, alleging medical negligence on the part of the doctors of Max Super Specialty Hospital, Saket, New Delhi, in the

treatment administered to the complainant's wife Smt. Sangeeta, resulting in her death on 13.03.2019, was confirmed by the Delhi Medical Council.

- (xii) The Order of the Disciplinary Committee in complaint No.2770 a representation from Police Station, Greater Kailash-I, New Delhi-110048, seeking medical opinion on a complaint of Smt. Jyoti Sharma, r/o- House o.55, Sarwal Colony, Jammu, alleging medical negligence in the treatment of complainant husband Shri. Kaushal Sharma at SCI Hospital, M-4 Greater Kailash, Part-1, New Delhi-110048, resulting in his death, was confirmed by the Delhi Medical Council.
- (xiii) The Order of the Disciplinary Committee in complaint No.2793 of Shri Piyush Chandra r/o 11 Floor B-56, Vasant Kunj Enclave, New Delhi-110070, alleging medical negligence on the part of Dr. Rajkumar of Indian Spinal Injuries Centre in the treatment of the complainant's mother Smt. Pramila Srivastava, resulting in her death on 23.3.2019, was confirmed by the Delhi Medical Council.
- (xiv) The Order of the Disciplinary Committee in complaint No.2798 of Smt. Madhulika Pandey, r/o- A-2/53, Hastsaal road, Uttam Nagar, New Delhi-110059, alleging medical negligence on the part of doctors of Mata Roop Rani MaggoHospital, Uttam Nagar, New Delhi, in the treatment administered to the complainant's husband Shri. Gaurav Pandey, resulting in his death on 02.05.2019 at Akash Health Care, where he subsequently received treatment, was confirmed by the Delhi Medical Council.
- (xv) The Order of the Disciplinary Committee in complaint No.2442 of Shri Amit Yadav, s/o Shri. Dhanvir Singh, r/o- B-3/223, Paschim Vihar, New Delhi-10063, alleging medical negligence on the part of doctors of Sri Balaji Action medical Institute, FC-34, A-4, Paschim Vihar, New Delhi-110063, in the treatment administered to the complainant's mother Smt. Chander Kala, resulting in her death, was confirmed by the Delhi Medical Council.

Dr. Subhash Aggarwal recused himself from the proceedings.

- (xvi) The Order of the Disciplinary Committee in complaint No.2736 of Shri Jagnath s/o Shri Rangi Ram r/o D-44, Vijay Viharm Phase-I Near Rohini Sector-4, Delhi-110085,

forwarded by the Public Grievance Monitoring System, alleging medical negligence in the treatment of complainant's wife Smt. Geeta Devi and her new born baby at Prashanti Nursing Home and Ambedkar Hospital, resulting in death of both new born baby and Smt. Geeta Devi, was confirmed by the Delhi Medical Council.

Dr. Vijay Dhankar recused himself from the proceedings.

- (xvii) The Order of the Disciplinary Committee in complaint No.2733 of Shri Sushant Sharma, Religare Health Insurance Company Ltd., Vipul Tech Square, Tower C, 3rd Floor, Sector 43, Gurgaon, Haryana-122009, forwarded by the Telangana State Medical Council, alleging professional misconduct on the part of Dr. Pushpendra Nath Renjen, Indraprastha Apollo Hospital, Sarita Vihar Delhi-Mathura Road, New Delhi-110076, in the treatment of Smt. Pooja Mehra, was confirmed by the Delhi Medical Council.
- (xviii) The Order of the Disciplinary Committee in complaint No.2760 of Smt. Sangeeta Sharma r/o RZ-661/A Kailash Puri, Nasir Pur Road, Palam Colony Delhi-110045, alleging medical negligence on the part of doctors of Aakash Hospital, Hospital Plot, Road No. 201, Sector-3, Dwarka, New Delhi-110075, in the treatment of complainant's husband Shri Sanjeev Sharma, resulting in his death on 12.2.2019, was confirmed by the Delhi Medical Council.

The Council further confirmed the punishment of warning awarded by the Disciplinary Committee to Dr. V.K. Ranga (Dr. Vinod Kumar Ranga, Delhi Medical Council Registration No.DMC/R/371); however, since, Dr. V.K. Ranga is currently not registered with the Delhi Medical Council (his registration expired on 02nd May, 2017); a copy of this Order be sent to the National Medical Commission with a request to take cognizance of this Order and take necessary action against Dr. V. K. Ranga

The Council further observed that the Order directing the issuance of warning to Dr. Sunil Kumar Negi shall come into effect after 60 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (xix) The Order of the Disciplinary Committee in complaint No.3023 of Smt. Natasha Sachdeva, r/o- House No.89A, Gali No.10, Balbir Nagar, Nala Paar, Shahdara, Delhi-110032, forwarded by Addl. Dy. Commissioner of Police, Shahdara District, Delhi, was confirmed by the Delhi Medical Council.

The Council also confirmed the punishment of removal of name of Dr. Raj Pal Singh Rohilla (Dr. Raj Pal Singh, Delhi Medical Council Registration No.4311) for a period of 30 days awarded by the Disciplinary Committee.

The Council further observed that the Order directing the removal of name from the State Medical Register of Delhi Medical Council shall come into effect after 60 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (xx) The Order of the Disciplinary Committee in complaint No.2812 of Shri Umesh Bansal, Office of the Superintending Engineer, President's Estate Circle, Central Public Works Department, Rashtrapati Motor Garage, Sch 'A', President's Estate, New Delhi-110004, forwarded by the Delhi Medical Association, seeking verification of genuineness of medical certificate issued by Dr. S. Rajan, New Rohini Hospital, 156, Pkt-00, Sector-1, Avantika (Rohini), Opp. Kamdhenu School, Delhi-110085 to Shri Gopal, was confirmed by the Delhi Medical Council.

The Council also confirmed the punishment of removal of name of Dr. S. Rajan (Dr. Sudarshan Rajan, Delhi Medical Council Registration No.15037) for a period of 30 days awarded by the Disciplinary Committee.

The Council further observed that the Order directing the removal of name from the State Medical Register of Delhi Medical Council shall come into effect after 60 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (xxi) The Order of the Disciplinary Committee in complaint No.3490 of Shri Dhirender Kumar House No. E-1207, Jahangirpuri, Delhi-110033, alleging medical negligence on the part of doctors of Adarsh Multi Speciality Hospital and Trauma Centre A-12, Sarai Pipal Thala, Extn, Adarsh Nagar, New Delhi- 110033, in the treatment of complainant's son Master Lakshay Kumar, resulting in his death on 22.10.2021, was confirmed by the Delhi Medical Council.

The Secretary informed that there are no minutes of the Finance Committee of the Delhi Medical Council on which discussion is required, as no meeting of the Finance Committee of the Delhi Medical Council had been convened.

7. To discuss digitalization of the records of the Delhi Medical Council with regard to outsourcing of records.

Due to paucity of time this agenda was not deliberated.

8. Any other item with permission of Chair.

- (i) A representation dated 17th October, 2023 from the permanent employees of the Council regarding Grant of Bonus to the permanent employees of the Delhi Medical Council for the year 2022-2023, was taken up for consideration before the Council.

The Secretary informed that in the last financial year (2022-2023), the Council sanctioned the Productivity Linked Bonus (PLB) for the financial year 2021-2022 to the permanent employee of the Council, equivalent to 78 (seventy- eight) days wages i.e. Rs.17,951/- (rupees seventeen thousand nine hundred fifty one), as granted by the Railway Board, Ministry of Railways, Govt. of India.

Similarly, in the current financial year (2023-2024), Railway Board, Ministry of Railways, Govt. of India vide its letter No.E(P&A)II/2023/PLB-1 RBE No.117/2023, New Delhi Dt. 18.10.2023 (appended herewith as **Annexure 'B'**), has sanctioned the Productivity Linked Bonus (PLB) for the financial year 2022-2023, equivalent to 78 (seventy- eight) days wages to all eligible non-gazetted Railways employees and decided that all eligible employees may be paid an amount of Rs.17,951/- (rupees seventeen thousand nine hundred fifty one) towards the Productivity Linked Bonus (PLB) for the financial year 2022-2023.

In view of the above, the Council unanimously decided the Endorsement of the letter No.E(P&A)II/2023/PLB-1 RBE No.117/2023, New Delhi Dt. 18.10.2023 of the Railway Board, Ministry of Railways, Govt. of India. Accordingly, the Council sanctioned the aforementioned Productivity Linked Bonus to the following permanent employees of the Council (mentioned in the following table) and directed that an amount of Rs.17,951/(rupees seventeen thousand nine hundred fifty-one) should be paid to them.

Further, an amount of Rs.7,000/- is sanctioned to rest of employees of the Council (six temporary employees and two outsourced employees) as a grant of bonus.

- (ii) A representation dated 16th October, 2023 from six permanent employees of the Delhi Medical Council regarding their upgradation in the next-scale, was taken up for consideration before the Delhi Medical Council.

The Council decided that there is no merit on the aforementioned representation dated 16th October, 2023 from six permanent employees of the Delhi Medical Council; hence, stands rejected.

- (iii) A representation dated 20th October, 2023 from the permanent employees of the Council regarding encashment of surplus earned leave, was taken up for consideration before the Delhi Medical Council.

The Council decided that there is no merit on the aforementioned representation dated 20th October, 2023 from the permanent employees of the Delhi Medical Council; hence, stands rejected.

- (iv) A representation dated 30th October, 2023 of Poonam Sharma and Kamal Singh, temporarily employees of the Council regarding increment of salary, was taken up for consideration before the Delhi Medical Council.

The Council decided an increment of 10% in their salary, be given to the them.

- (v) Council members conferred and deliberated at length and reached a consensus that members be provided with good high technology utility item which will help them to upgrade themselves and perform better thereby delivering better output with their time constraints, with reference to their job assignment in the council. Finally, it was decided to provide them a good quality mobile phone for the same.
