Minutes of the Council meeting of the Delhi Medical Council held on 08th December, 2023 in Conference Room, Ground Floor, B-Wing, Block-1, DMRC IT Park, Shastri Park, New Delhi-110053.

A meeting of the Delhi Medical Council was convened 08th December, 2023 for 2.30 p.m. in Conference Room, Ground Floor, B-Wing, Block-1, DMRC IT Park, Shastri Park, New Delhi-110053.

The meeting was adjourned at 2.30 p.m. due to lack of quorum. The meeting was reconvened at 3.00 p.m.

2. Action taken report of minutes of the meeting held 06th November, 2023.

3. To discuss cases of medical negligence and unethical conduct.

- (i) The Order of the Executive Committee in Complaint No. 3834-a representation from Police Station North Rohini seeking medical opinion in respect of death of Ms. Sarita w/o Nandu, r/o C-301, Gali No. 9, Majlis Park Adarsh Nagar, Delhi, allegedly due to medical negligence on the part of doctors of BSA Hospital Sector-6 Rohini Delhi-110086, was confirmed by the Delhi Medical Council.
- (ii) The Order of the Executive Committee in complaint No. 3578- a representation from Police Station, I.P Estate, Delhi, seeking medical opinion on a complaint of Smt Jyoti, r/o- House No. O-97, Mangolpuri, Delhi, alleging medical negligence on the part of doctors of Lok Nayak Hospital, New Delhi, in the treatment administered to complainant's husband Shri Kuldeep Singh, resulting in his death on 28.06.2020, was confirmed by the Delhi Medical Council.
- (iii) The Order of the Executive Committee in complaint No.3299 of Dy. Medical Superintendent, ESIC Hospital, Okhla, New Delhi, alleging professional misconduct on the part of Dr. Preeti Sharma, House No.18A, Pocket-9, DDA Flats, Gomti Apartment, Kalkaji Extension, New Delhi-110019, was confirmed by the Delhi Medical Council.
- (iv) The Order of the Executive Committee in complaint No.3822 of Shri Vishal Rawat s/o Shri late Banwari Lal r/o H.No. 146A, Gujjar Dairy Gautam Nagar, New Delhi-110049, alleging medical negligence on the part of doctors of Diyos Hospital A-1/26, Safdarjung Enclave, New delhi-110029, in the treatment of complainant's father Shri Banwari Lal, resulting in his death on 16.02.2023, was confirmed by the Delhi Medical Council.
- (v) The Order of the Executive Committee in complaint No.3312 of Sarvodaya Hospital and Research Centre, Sector 8, Faridabad, alleging professional misconduct on the part of Dr.

Priya Rai, House No.1510, Sector 08, Faridabad, Haryana-121006, was confirmed by the Delhi Medical Council.

- (vi) The Order of the Executive Committee in complaint No.3351 of Smt. Sarita, r/o- 83/13, Block A-1, Top Floor, Mohan Garden, New Delhi-110059, alleging medical negligence on the part of doctors of Tarak Hospital, C-7, Jai Bharat Enclave, Dwarka more, New Delhi, in the treatment administered to complainant's husband Shri Randhir, resulting in his death on 28.05.2021 at Deen Dayal Upadhyay Hospital where he subsequently received treatment, was confirmed by the Delhi Medical Council.
- (vii) The Order of the Executive Committee in complaint No.3503 of Shri Navneet Bhardwaj s/o Shri Vijay Bhardwaj r/o 7A Sarojani Nagar, Shasti Nagar, Delhi-110031, alleging medical negligence on the part of Dr. Nupur Pagore of Jain Charitable Hospital Street No. 5, Raghubar Pura No.2, Gandhi Nagar, Delhi-110031, in the treatment of complainant's wife Smt. Sonam Bhardwaj, was confirmed by the Delhi Medical Council.
- (viii) The Order of the Executive Committee in complaint No.3903- a representation from Police Station Madhu Vihar, seeking medical opinion on a complaint of Smt. Sarita r/o D-74B Street No. 03, Laxmi Nagar, New Delhi, alleging medical negligence on the part of doctors of Max Hospital Patparganj, Delhi-110092, in the treatment of complainant's mother Smt. Shanta, resulting in her death on 27.05.2023, was confirmed by the Delhi Medical Council.
- (ix) The Order of the Executive Committee in complaint No.3905 of Shri Praveen Chopra r/o 46-B, LIG Flats, IInd Floor, Rajouri Garden, New Delhi-1100027, alleging medical negligence on the part of Dr. Ritin Goyal of Insight Eye Clinic, J-9/5, Rajouri Garden, New Delhi-110027, in the treatment of complainant, was confirmed by the Delhi Medical Council.
- (x) The Order of the Disciplinary Committee in complaint No. 2817 of Shri Chaman Singh s/o Shri Amichand r/o A-386, Part-6, Main Circular Road, Near CRPF Camp, Sonia Vihar Delhi-110094, alleging medical negligence on the part of doctors of Chacha Nehru Bal Chikitsalaya Geeta Colony, Delhi-110031, in the treatment of complainant's baby Kavya, resulting in her death on 25.11.2018, was confirmed by the Delhi Medical Council.
- (xi) The Order of the Disciplinary Committee in complaint No.1356 of representation from Dr. S.K. Bansal, Additional Medical Superintendent, (Admn.), Office of the Medical Superintendent, Lok Nayak Hospital, Govt. of NCT of Delhi, New Delhi-110002, alleging

Professional misconduct on the part of Resident Doctor of Medicine and Surgery, in the treatment administered to late Shri Pappu, resulting in his death on 27.4.14, was taken up for confirmation before the Delhi Medical Council.

In light of the observations made in the Order of the Disciplinary Committee, the Council allows the withdrawal of the representation No.F.AMS(A)/24/LNH/2014/710 dated 09th June, 2014 of Additional Medical Superintendent (Admn.), Lok Nayak Hospital, Govt. of NCT of Delhi, New Delhi and thus, order closure of these proceedings; hence, the same stands closed.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (xii) The Order of the Disciplinary Committee in complaint No. 3800 a representation from police station Baba Hari Das Nagar Delhi seeking medical opinion, on a complaint of Shri Karam Veer r/o Flat No. 08, Type-III, New Block Group Centre CRPF Jharoda Kalan Delhi-110072, alleging medical negligence on the part of doctors of Composite Hospital CRPF Jharoda Kalan New Delhi-110072 and Venkateshwar Hospital Dwarka, New Delhi-110075, in the treatment of complainant's wife Smt. Pooja, resulting in her death at Manipal Hospital, where she was subsequently received treatment, was confirmed by the Delhi Medical Council.
- (xiii) The Order of the Disciplinary Committee in complaint No.3849 of Shri Aayush Batra s/o Shri Inder Sain Batra, r/o 2nd Floor, 2/2D/1C, Gali No.8, Near Krishna Nagar Police Station East Azad Nagar, Krishna Nagar, Delhi-110051, alluding to a Court order dated 17.4.2023 in which certain observations have been made by the Hon'ble Judge Family Court, Central District THC in its order dated 17.4.2023 in case GP No. 46/22 Aayush Batra vs Prerna Batra against Dr. Rahul Sharma, was confirmed by the Delhi Medical Council.

The Council further confirmed the punishment of warning awarded by the Disciplinary Committee to Dr. Rahul Sharma (Delhi Medical Council Registration No.21732).

The Council further observed that the Order directing the issuance of warning shall come into effect after 60 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (xiv) The Order of the Disciplinary Committee in complaint No.3451 of Shri Sachin Gupta A-6, 3rd Floor, Sardar Nagar, near C.C. Colony, Delhi-110009, alleging medical negligence on the part of doctors of Fortis Hospital, Shalimar Bagh, Delhi, in the treatment of complainant's daughter Baby Ananya Gupta, resulting in her death, was confirmed by the Delhi Medical Council.

The Council further confirmed the punishment of warning awarded by the Disciplinary Committee to Dr. Hima Goyal (Delhi Medical Council Registration No.DMC/R/12278).

The Council further observed that the Order directing the issuance of warning shall come into effect after 60 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (xv) The Order of the Disciplinary Committee in complaint No. 3194-a representation from Dy. Commissioner of Police, Dwarka District, seeking medical opinion on a complaint of Sub Major Shri Krishan Sharma, RZ-179, Street No. -10, Gopal Nagar, New Delhi-110043, alleging medical negligence on the part of doctors of Manipal Hospital and Venkateshwar Hospital Dwarka Sector-18A, New Delhi-110075, in the treatment of complainant's son Shri Satish Kumar Sharma, resulting in his death on 22.11.2020, was taken up for confirmation of the Delhi Medical Council.

Whilst confirming the Order of the Disciplinary Committee, the Council observed that in the facts and circumstances of this case, a copy of this Order be also sent to the Directorate General of Health Services, Govt. of NCT of Delhi and the Directorate

General of Health Services, Govt. of India with a request that necessary directions may be issued to the hospitals/nursing homes, functioning under their jurisdiction to make a portal on their website in regard to the availability (Real Time Disposed) of beds for general public.

The Council further confirmed the punishment of warning awarded by the Disciplinary Committee to Dr. Gulshan Battan (Delhi Medical Council Registration No.69334) and Dr. Ritesh Sanguri (Delhi Medical Council Registration No.43813) with a direction that they should undergo 12 hours of Continuing Medical Education (C.M.E.) each on the subject related to 'Acute Coronary Syndrome', within a period of three months from the date of the Order and submit a compliance report to this effect to the Delhi Medical Council

The Council further observed that the Order directing the issuance of warning shall come into effect after 60 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (xvi) The Order of the Disciplinary Committee in complaint No. 2537 of Shri. Anil Kumar Singh s/o late Shri Jai Govind Singh r/o- 13/490, Lodhi Colony, New Delhi-110003, forwarded by the Medical Council of India, alleging professional misconduct on the part of Dr. Dinesh Kumar Yadav, Department of Pediatrics, PGIMER, Dr. RML Hospital, New Delhi, was confirmed by the Delhi Medical Council.

The Council further confirmed the punishment of warning awarded by the Disciplinary Committee to Dr. Dinesh Kumar Yadav (Dr. Dinesh Kumar, Delhi Medical Council Registration No.9770).

The Council further observed that the Order directing the issuance of warning shall come into effect after 60 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

4. To discuss about the Minutes of the Anti-Quackery Committee.

The minutes of the meeting of the Anti-Quackery Committee of the Delhi Medical Council held on 29th November, 2023 were circulated to all the members present, were confirmed.

5. To discuss about the Minutes of the Finance Committee.
