The following agenda was discussed:-

1. To brief members about the show cause notice/memo received by DMC/its officers (Registrar and President) based on complaints filed with the Govt. of NCT.

DMC President, Dr. Arun Gupta informed the members about a recent communication from the Govt. of Delhi based on two complaints received by the government from Dr. Ajay Gambhir and Mr Himanshu Singhal

Dr Girish Tyagi recused himself from the meeting.

President- Dr. Arun Gupta requesting Vice President- Dr. Naresh Chawla to record the minutes of today's meeting.

The members were briefed about the contents of the communication received from the government as well as the detailed reply sent by Registrar DMC, Dr. Girish Tyagi and President, DMC along with all enclosures of documents sent to the government.

Members noted with satisfaction that a factual reply to all points raised by the government has been sent appropriately.

Members of the council noted with great concern that one of the former member of the council, Dr. Ajay Gambhir, the person who lost the recently concluded DMA elections to Dr. Girish Tyagi has lodged a blatantly false, malicious complaint against the council in general and Registrar and the President in particular. His attempts are to mis lead the government with false allegations. His allegations are totally false and mischievous and smack of personal vengeance as he has lost DMA elections.

The Council also noted that the other complainant Mr. Himanshu Singhal is in connivance with Dr Ajay Gambhir. Mr Himanshu Singhal is the person who lost his case in Delhi Medical Council few years back. So now both these complainants holding personal grudges against DMC Registrar, President and DMC in general, have embarked on a path of vendetta, combined together and filed a complaint with the government of Delhi.

The Council noted with satisfaction and appreciation that Delhi Medical Council Registrar and the President have given all the answers factually and correctly to questions asked from Delhi Medical Council which are more of procedural in nature. The President, DMC has also

provided facts and his comments as asked for by the government.

Few questions asked by the government were regarding extension of tenure of Registrar from

60 years to 65 years, which the Council noted was as per rule of the government and was

endorsed by the council in 2019. The Council reiterated that all decisions taken by the

Council in this matter on earlier occasions stand valid even today and the same are endorsed

by this Council also. The council also noted with satisfaction that legal opinion obtained from

a respected legal counsel has also put the facts in proper perspective.

The council noted with satisfaction that appropriate factual replies to all points and enquiries

raised by the government of Delhi have been submitted by the council. The council also

endorsed and approved all factual statements and reply submitted by the Registrar.

The members expressed their anguish over attempt by Dr Ajay Gambhir, a former member of

DMC to tarnish the image of DMC by levelling false and motivated allegations against DMC,

its Registrar and President. It was noted with dismay how can a former member of DMC who

was party to all decisions taken by the council got in connivance with a man who lost his

complaint in DMC to spread false, misleading and defamatory allegations against the council.

Members urged and authorised the President, DMC to initiate the process to see that Dr.

Ajay Gambhir is held accountable for his mis-deeds. The council unanimously authorized the

President, Dr.Arun Gupta to seek opinion and initiate suitable action including show cause

notice against Dr. Ajay Gambhir in the matter as may be advised.

Meeting ended with vote of thanks to the chair.
