A meeting of the Delhi Medical Council was convened 11<sup>th</sup> May, 2023 for 2.30 p.m. in Conference Room, Ground Floor, B-Wing, Block-1, DMRC IT Park, Shastri Park, New Delhi-110053.

The meeting was adjourned at 2.30 p.m. due to lack of quorum. The meeting was reconvened at 3.00 p.m.

# 2. Action taken report of minutes of the meeting held 10<sup>th</sup> April, 2023.

### 3. To discuss cases of medical negligence and unethical conduct.

(i) The Order of the Executive Committee in complaint No. 3069 of Shri Shubham Bhatnagar, 551-A, Sector-3, R.K. Puram, New Delhi-110022, alleging medical negligence on the part of doctors of Primus Hospital, Chanakya Puri, New Delhi, in the treatment administered to the complainant's mother Smt. Shalini Bhatnagar at Primus Hospital, resulting in her death on 09.06.2020, was confirmed by the Delhi Medical Council.

- (ii) The Order of the Executive Committee in complaint No.3267 of Shri Arun Kumar Kannojis, 139/18, 13, Civil Lines, Roorkee-242667, District Haridwar, Uttarakhand, forwarded by the Directorate General of Health Services, Govt. of NCT of Delhi, alleging medical negligence on the part of the doctors of Venkateshwar Hospital, Sector-18 A, Dwarka, in the treatment administered to the complainant's wife Smt. Vidhya Devi at Venkateshwar Hospital, resulting in his death on 16.09.2020, was confirmed by the Delhi Medical Council.
- (iii) The Order of the Executive Committee in complaint No.3308 of Shri Mohd. Nadeem Khan, Chamber No.618, western wing, Tis Hazari Court, New Delhi, alleging medical negligence on the part of doctors of Sabharwal Hospital, 2911-B, 2906, Sir Syed, Ahmed Road, Daryaganj, New Delhi-110002, in the treatment administered to complainant's wife Smt Anam, was confirmed by the Delhi Medical Council.
- (iv) The Order of the Executive Committee in complaint No.3631-a representation from Police Station Dwarka North seeking medical opinion on a complaint of Smt. Anita Rahil w/o Shri Yashpal r/o Plot No. 34-B, Munirka Kunj, Dindarpur, Najafgarh, New Delhi-110043, alleging medical negligence on the part of doctors of Venkateshwar Hospital Dwarka, New Delhi, in the treatment of complainant, was confirmed by the Delhi Medical Council.
- (v) The Order of the Executive Committee in complaint No.3577-a representation from Police Station, Dwarka North, New Delhi-110059, forwarding a complaint of Shri Narender Singh s/o Sh. Sultan Singh, r/o- RZ-252, B Block, Nanda Enclave, Gopal Nagar, Najafgarh, New Delhi-110043, alleging medical negligence on the part of doctors of Venkateshwar Hospital, Sector 18A, Dwarka, New Delhi-110075, in the treatment administered to complainant's wife Smt Raj Kaur, resulting in her death on 16.03.2021, was confirmed by the Delhi Medical Council.
- (vi) The Order of the Disciplinary Committee in complaint No.2946-a representation from police station, Shalimar Bagh, Delhi, seeking medical opinion on a complaint of Shri Karan Khanna, r/o- B-4/172 A, Keshav Puram, Delhi, alleging medical

negligence on the part of doctors of Fortis Hospital, Shalimar Bagh, New Delhi-110088, in the treatment of complainant's father Shri Kamal Khanna, resulting in his death, was confirmed by the Delhi Medical Council.

Dr. Arun Kumar Gupta recused himself from the proceedings.

(vii) The Order of the Disciplinary Committee in complaint No.3290 of Smt Rajni Ahuja, r/o- Sanjay Nagar Mahendra Park, Adarsh Nagar, North West, Delhi-110033, alleging medical negligence on the part of the Dr. Meera Sethi and Vinayak Hospital, Derawal Nagar, Model Town, Delhi-110009, in the treatment administered to the complainant at Vinayak Hospital, was confirmed by the Delhi Medical Council.

The Council also confirmed the punishment of removal of name of Dr. Meera Sethi(Delhi Medical Council Registration No.3872) for a period of 15 days awarded by the Disciplinary Committee.

The Council further observed that the Order directing the removal of name from the State Medical Register of Delhi Medical Council shall come into effect after 60 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

(viii) The Order of the Disciplinary Committee in complaint No.3049 of Shri Laxman Saini, r/o, B-275, Gali No.1, Baba Colony, Burari, Delhi-110084, forwarded by the Akhil Bharat Hindu Mahasabha, alleging medical negligence on the part of Dr. Niharika and Medlife Hospital, Khasra No.346, Main Road, Lal Dora, Burari, Dellhi-110084, in the treatment administered to the complainant at Medlife Hospital, was confirmed by the Delhi Medical Council.

- (ix) The Order of the Disciplinary Committee in complaint No.3367-a representation from Dy. Commissioner of Police, Central District, Delhi, seeking medical opinion in respect of death of Shri Uttam Behra, allegedly due to medical negligence in the treatment administered to Shri Uttam Behra at N.C. Joshi Memorial Hospital, Karol Bagh, Delhi, resulting in his death on 23.01.2021, was confirmed by the Delhi Medical Council.
- (x) The Order of the Disciplinary Committee in complaint No.1785 of Shri Devashish Bhattacharyya, r/o- D-II/A-2727, Netaji Nagar, New Delhi-110023, forwarded by the Directorate of Health Services, Govt. of NOT of Delhi, alleging medical negligence on the part of Dr. Ashish Dewan of Orthonova Hospital, Dr. P.S. Gill and Fortis Flt. Lt. Rajan Dhall Hospital, Sector B, Pocket-1, Aruna Asaf Ali Marg, Vasant Kunj, New Delhi-110070, in the treatment administered to the complainant's father Late Shri Bireswar Bhattarcharyya at Fortis Flt. Lt. Rajan Dhall Hospital, resulting in his death at St. Stephen Hospital where he was subsequently treated, was confirmed by the Delhi Medical Council.
- (xi) The Order of the Disciplinary Committee in complaint No.2431-a suo moto notice of a news item published in the The Indian Express dated 05<sup>th</sup> April, 2018, alleging medical negligence on the part of the doctors of All India Institute of Medical Sciences, for performing wrong surgery on a patient,, was taken up for confirmation before the Delhi Medical Council.

Dr. Maneesh Singhal recused himself from the proceedings.

Whilst confirming the Order of the Disciplinary Committee, the Council observed that the punishment of removal of name of Dr. Simranjeet Singh (Delhi Medical Council Registration No.DMC/R/13915) and Dr. Raghavendra Y.S. (Delhi Medical Council Registration No.95511) for a period of 07 days awarded by the Disciplinary Committee; similarly, the punishment of removal of name of Dr. Manjunath M. Pol (Delhi Medical Council Registration No.67630) for a period of 30 days awarded by the Disciplinary Committee, is highly inadequate, as the lapses highlighted are very

serious in nature viz.- doing unwarranted surgical procedure and tampering with the records to cover-up the act. The Council, therefore, directs that name of Dr. Simranjeet Singh (Delhi Medical Council Registration No.DMC/R/13915) and Dr. Raghavendra Y.S. (Delhi Medical Council Registration No.95511) be removed from the State Medical Register of the Delhi Medical Council for a period of 30 days; similarly, the name of Dr. Manjunath M. The Council further observed that in the facts and circumstances of this case, the punishment of removal of name of Dr. Manjunath Bale (Delhi Medical Council Registration No.73193) for a period of 07 days awarded by the Disciplinary Committee was not warranted; however, a warning be issued to Dr. Manjunath Bale(Delhi Medical Council Registration No.73193) for the shortcomings, in not properly recording his notes in OPD consultation; however, however, since, Dr. Manjunath Bale is currently not registered with the Delhi Medical Council (his registration expired on 08<sup>th</sup> October, 2020) but registered with the Karnataka Medical Council under registration No.87631 dated 27<sup>th</sup> March, 2010; a copy of this Order be sent to the Karnataka Medical Council with a request to take cognizance of this Order and take necessary action against Dr. Manjunath Bale.

The Council further observed that the Order directing the removal of name of Dr. Simranjeet Singh (Delhi Medical Council Registration No.DMC/R/13915), Dr. Raghavendra Y.S. (Delhi Medical Council Registration No.95511) and Dr. Manjunath M. Pol (Delhi Medical Council Registration No.67630) from the State Medical Register of Delhi Medical Council shall come into effect after 60 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (xii) The Order of the Disciplinary Committee in complaint No.2507- a representation form Police Station, Greater Kailash, seeking medical opinion on a complaint of Mr. Adam Berman, r/o-1734, Waller Street, San Fracisco CA 94117, USA, alleging medical negligence and professional misconduct on the part of Dr. Shivani Sachdev Gour, Dr. Vishal Dutt Gour and ISIS Hospital (A unit of SCI Healthcare), A-1, Kailash Colony, Ground Floor, New Delhi-110048, was confirmed by the Delhi Medical Council.
- (xiii) The Order of the Disciplinary Committee in complaint No.3453 -a representation from Police Station Safdarjung Enclave, seeking medical opinion on a complaint of Shri Karan Manganani r/o T-1, Santosh Apartments, 287, Adarsh Nagar, Jaipur, 302001, alleging medical negligence on the part of doctors of Dezire Clinic, C-6/3, SDA, Hauzkhas, New Delhi-110016, in the treatment of complainant's mother Smt. Shalini Bhambhani, resulting in her death at Max Healthcare Hospital Saket, on 04.10.2021, where she subsequently received treatment, was confirmed by the Delhi Medical Council.

The Council also confirmed the punishment of removal of name of Dr. Prashant Yadav (Delhi Medical Council Registration No.17096) for a period of 180 days awarded by the Disciplinary Committee with a direction that he should undergo 06 hours of Continuing Medical Education (C.M.E.) on the subject related to 'Aesthetic Surgery (Specially Liposuction) within a period of three months from the date of the Order and submit a compliance report to this effect to the Delhi Medical Council.

The Council further observed that the Order directing the removal of name from the State Medical Register of Delhi Medical Council shall come into effect after 60 days from the date of the Order. This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.
