(xx) The Order of the Disciplinary Committee in complaint No.3791- a Court Order dated 14th February, 2023 in Application No.235/2023, FIR No.450/2022 State Vs Ashu Chauhan @ Rajan Kumar, PS Vasant Kunj South, U/s 323/325/341/379/506/452/147/148/34 IPC, 5 in F.I.R. No. 298/12, P.S. Adarsh Nagar, in which certain observations have been made by the learned Additional Sessions Judge, New Delhi District, New Delhi against Dr. Gopal Bhagat of Bhagat Clinic & Hospital, 281 P-15, Ward No.2, Mehrauli, New Delhi-110030, was confirmed by the Delhi Medical Council.

The Council also confirmed the punishment of removal of name of Dr. Gopal Bhagat(Delhi Medical Council Registration No.108238) for a period of 180 days awarded by the Disciplinary Committee.

The Council further observed that the Order directing the removal of name from the State Medical Register of Delhi Medical Council shall come into effect after 60 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

(xxi) The Order of the Disciplinary Committee in complaint No.3812-an Order dated 24.03.2023, in the matter titled State Vs. Ajay Gupta (Cr. Case no. 7049/2019 FIR No.150/2018 Keshav Puram) passed by the Hon'ble Court, wherein certain observations have been made by the Learned Metropolitan Magistrate in regard to preparation of a post mortem report by Dr. Sandeep Garg, was confirmed by the Delhi Medical Council.

The Council further confirmed that Dr. Sandeep Kumar Garg shall undergo 03 hours of Continuing Medical Education (C.M.E.) on the subject related to 'Asphyxial Death', within a period of three months from the date of the Order and submit a compliance report to this effect to the Delhi Medical Council.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

(xxii) The Order of the Disciplinary Committee in complaint No.1418- representation from Police Station, Vivek Vihar, East Distt., New Delhi, seeking medical opinion in respect of death of Late Bhagmali w/o Shri Jagbir Singh, allegedly due to medical negligence on the part of doctors of I.G.E.S.I. Hospital, resulting in her death on 29.10.2012 at I.G.E.S.I.C. Hospital, Jhilmil, Delhi-110095, was confirmed by the Delhi Medical Council.

The Council further confirmed the punishment of warning awarded by the Disciplinary Committee to Dr. Amit Aggarwal (Dr. Amit Anil Aggarwal, Delhi Medical Council Registration No.30090) and Dr. Alok Kumar (Delhi Medical Council Registration No.108004).

The Council further observed that the Order directing the issuance of warning shall come into effect after 60 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

(xxiii) The Order of the Disciplinary Committee in complaint No.3833 of Smt. Preeti w/o Shri Sumit r/o K-478 Dakshinpuri, New Delhi-110062, alleging medical negligence on the part of the doctors of Mehta Hospital, F-1st, 108A- Virat Road, Madangir, New Delhi-110062, in the treatment of complainant's husband Shri Sumit, was taken up for confirmation before the Delhi Medical Council.

Whilst confirming the Order of the Disciplinary Committee, the Council observed that since the ETCO₂ monitoring is not mandatory; punishment of warning awarded by the Disciplinary Committee to Dr. Vishwa Priya Sharma (Dr. Vishwa Priya, Delhi Medical Council Registration No.25082) and Dr. Rudra Prasad Mishra (Delhi Medical Council Registration No.70856) is not warranted; however, it is advisable that provision of ETCO₂ during laparoscopic surgery should be made in a hospital, set-up. In view of the same, there is no requirement of forwarding this matter to the Directorate General of Health Services, Govt. of NCT of Delhi.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed through majority decision.

(xxiv) The Order of the Disciplinary Committee in complaint No.3239- a representation from Police Station, Hauz Qazi, Central District, Delhi, seeking medical opinion on a complaint of Smt. Samreen, w/o Shri Umar Nawaz, 226, Gali Garahaiy, Matia Mahal Bazaar, Jama Masjid, Delhi-110006, alleging medical negligence on the part of Dr. Kuljeet Gill and Rehmani Nursing Home, 5106 (Lal Building) Kucha Noorullah Khan, Phatak Bans, Sirklwalan, Delhi-110006, in the treatment of complainant, was taken up for confirmation before the Delhi Medical Council.

Whilst confirming the Order of the Disciplinary Committee, the Council observed that the following conclusion appearing in Order of the Disciplinary Committee be expunged, as the same is not warranted.

"however, a warning be issued to Dr. Kuljit Gaur Gill (Delhi Medical Council Registration No.12774) for the shortcomings in the treatment highlighted hereinabove, with the advice to be careful in future".

The Council further observed that in facts and circumstances of this case, a warning be issued to Dr. Kuljit Gaur Gill (Delhi Medical Council Registration No.12774) for claiming herself to be a gynaecologist without holding any requisite medical qualification and she is further directed to refrain from claiming herself to be a gynaecologist.

The Council further observed that the Order directing the issuance of warning shall come into effect after 60 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

(xxv) The Order of the Disciplinary Committee in complaint No.3203 of Shri Pradeep Bhushan Goel r/o F-11A (G-8Area) Hari Nagar, Delhi-110064, forwarded by Medical Council of India, alleging medical negligence on the part of Dr. Arun Bhanot, Aum Clinics Flat No. 2, Akshardham Apartments, Pocket-3, Sector-19, Dwarka, New Delhi-110075, in the treatment of complainant's mother Smt. Prakash Goel at Columbia Asia Hospital, Block-F, Near Gol Chakkar, Palam Vihar, Gurgaon Haryana-122017, resulting in her death on 15.10.2020, was taken up for confirmation before the Delhi Medical Council.

Whilst confirming the Order of the Disciplinary Committee, the Council observed that facts and circumstances of this case, the punishment of warning awarded by the Disciplinary Committee to Dr. Arun Bhanot (Delhi Medical Council Registration No.31228), Dr. Ankush Garg (Delhi Medical Council Registration No.14285) and Dr. Arvind Singh Jhala, was not warranted. In view of the same, there is no requirement of forwarding this matter to the Haryana Medical Council.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

(xxvi) The Order of the Disciplinary Committee in complaint No.2720 of Shri Naveen Mittal A-1/42, First Floor, Sector-11, Rohini, New Delhi-110085 alleging medical negligence on the part of doctors of Saroj Super Specialty Hospital, Madhuban Chowk, Rohini, Delhi-110085, in the treatment administered to the complainant's father Shri Paras Ram Mittal, resulting in his death on 30.09.2018, was taken up confirmation before the Delhi Medical Council.

Whilst confirming the Order of the Disciplinary Committee, the Council observed that the following observations, mentioned at the point (3) of the Disciplinary Committee's Order be expunged and substituted, as under:-

"there was no need for advising ECG by Dr. B.K. Agrawal", is expunged and substituted with "Dr. B.K. Agrawal did not erred in not advising E.C.G.".

The Disciplinary Committee, however, directed that a warning be issued to Dr. B.K. Agrawal (Dr. Bijaya Kumar Agrwal, Delhi Medical Council Registration No.14178) for claiming himself to be a cardiologist, as the same is borne out from the prescription dated 27th September, 2018 of Narayani Health Services. He is further directed to refrain from claiming herself to be a cardiologist.

The Council also observed that the following observations mentioned at the point (4) of the Disciplinary Committee's Order be expunged, as the patient died during the process of evaluation of chest pain right side when the patient presented on 30th September, 2018, E.C.G., chest x-ray were advised. The chest x-ray was done; however, the patient died, which does not constitute negligence; hence, the punishment of removal of name of Dr.

Akhil Vohra (Delhi Medical Council Registration No.989), awarded by the Disciplinary Committee, is not warranted.

"Dr. Akhil Vohra erred in not subjecting the patient to ECG examination, which is a basic investigation, expected to be carried out in case of person of 72 years in age having complaint of chest pain. The result of ECG could have guided the doctors in making the correct diagnosis and administering the required treatment", is expunged.

However, Dr. Akhil Vohra is directed to undergo 15 hours of Continuing Medical Education (C.M.E.) on the subject related to 'Management of Case with Chest Pain', within a period of three months from the date of the Order and submit a compliance report to this effect to the Delhi Medical Council.

The Council further observed that the Order directing the issuance of warning to Dr. B.K. Agrawal shall come into effect after 60 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

(xxvii) The Order of the Disciplinary Committee in complaint No.3690- a representation from police Station Aman Vihar, seeking medical opinion on a complaint of Shri Rohit Kumar, alleging medical negligence on the part of the doctors of Ahuja Clinic and Shri Shyam Nursing Home, in the treatment of complainant's wife Smt. Kiran, resulting in her death on 19.6.2019, was confirmed by the Delhi Medical Council.

The Council also confirmed the punishment of removal of name of Dr. Rahul Gautam (Delhi Medical Council Registration No.31134) for a period of 30 days awarded by the Disciplinary Committee.

The Council further observed that the Order directing the removal of name from the State Medical Register of Delhi Medical Council shall come into effect after 60 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

(xxviii) The Order of the Disciplinary Committee in complaint No.2459- a representation from police station, Jahangir Puri, Delhi seeking medical opinion in respect of death of baby Tigu, allegedly due to medical negligence on the part of the doctors of Babu Jagjivan Ram Memorial Hospital, in the treatment administered to baby Tigu at Babu Jagjivan Ram Memorial Hospital, resulting in his death on 19.01.2018, was confirmed by the Delhi Medical Council.

The Council also confirmed the punishment of warning awarded by the Disciplinary Committee to Dr. Sunil Kumar Negi (Delhi Medical Council Registration No.81542) with a direction that he should undergo 08 hours of Continuing Medical Education (C.M.E.) on the subject related to 'Management of Burn Patient', within a period of three months from the date of the Order and submit a compliance report to this effect to the Delhi Medical Council. However, since the name of Dr. Sunil Kumar Negi (Delhi Medical Council Registration No.81542) already stood deleted from the State Medical Register of the Delhi Medical Council on account of non-renewal of registration with the Delhi Medical Council w.e.f. 08th October, 2022, a copy of this Order be also sent to the National Medical Commission and the Himachal Pradesh Medical Council where, as per record Dr. Sunil Kumar Negi was also registered under registration No.1649/2012 dated 09th June, 2012 for necessary action

The Council further observed that the Order directing the issuance of warning to Dr. Sunil Kumar Negi shall come into effect after 60 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

(xxix) The Order of the Disciplinary Committee in complaint No.2724- a representation form Police Station, Shakarpur, Delhi, seeking medical opinion on a complaint of Smt. Neha Kapooriya, alleging medical negligence on the part of the doctors of Walia Nursing Home, Laxmi Nagar, Delhi-110092 and Lal Bahadur Shastri Hospital, Near Kalyanvas Colony, Mayur Vihar Phase II, Mayur Vihar, Delhi, 110091, in the treatment administered of complainant's husband Shri Uttam Kumar, was confirmed by the Delhi Medical Council.

The Council also confirmed the punishment of warning awarded by the Disciplinary (Delhi Medical Council Registration Dr. Shailesh Kumar Committee to No.DMC/R/08510), Dr. Shefalika Sharma (Delhi Medical Council Registration No.DMC/R/17114) and Dr. Sachin Bhardwaj (Delhi Medical Council Registration No.71603) with a direction that they should undergo six hours of Continuing Medical Education (C.M.E.) on the subject related to 'Initial Assessment and Management of Trauma Patient', within a period of three months from the date of the Order and submit a compliance report to this effect to the Delhi Medical Council. However, since the name of Dr. Shailesh Kumar (Delhi Medical Council Registration No.DMC/R/08510) already stood deleted w.e.f. 24th July, 2022 from the State Medical Register of the Delhi Medical Council on account of non-renewal of registration with the Delhi Medical Council; a copy of this Order be sent to the National Medical Commission with a request to take cognizance of this Order and take necessary action against Dr. Shailesh Kumar

The Council further observed that the Order directing the issuance of warning shall come into effect after 60 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

(xxx) The Order of the Disciplinary Committee in complaint No.3307- of Shri Rajender Sharma through his son Pawan Vashisht, alleging professional misconduct on the part of Dr. Neel Shah of Indraprastha Apollo Hospital, in the treatment of complainant Shri Rajender Sharma, was confirmed by the Delhi Medical Council.

The Council also confirmed the punishment of warning awarded by the Disciplinary Committee to Dr. Neel Shah (Delhi Medical Council Registration No.1789)

The Council further observed that the Order directing the issuance of warning shall come into effect after 60 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed through majority decision.

(xxxi) The Order of the Disciplinary Committee in complaint No.2752- of Shri Faizan, forwarded by Directorate General of Health Services, alleging medical negligence in the treatment administered to the complainant's wife Smt. Yasmin at Shanti Mukand Hospital, resulting in her death on 3.12.2018, was taken up for confirmation before the Delhi Medical Council.

Whilst confirming the Order of the Disciplinary Committee, the Council observed the following observations, mentioned at point (2) of the Disciplinary Committee's Order, be expunged, as the same are not warranted.

"The high rate of mortality due to postpartum cardiomyopathy despite all measures, is a well-known fact."

The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.
