3. To discuss cases of medical negligence and unethical conduct.

- (i) The Order of the Executive Committee in Complaint No. 3830 of Shri Varun Kapoor s/o Shri Umesh Kapoor, r/o H.No. 519, 3rd Floor, west Parmanand Colony, Delhi-110009 alleging medical negligence on the part of Dr. Pankaj Anand of Pentamed Hospital, 7, Local Shopping Centre, Derawal Nagar, Ph-IV, Delhi-110009, in the treatment of complainant, was confirmed by the Delhi Medical Council.
- (ii) The Order of the Executive Committee in complaint No.2887- a representation from Dy. Commissioner of Police, West District, New Delhi seeking medical opinion on a complaint of Shri. Vijay Abrol, r/o- 24/18B, 1st Floor, Tilak Nagar, New Delhi-110018, alleging medical negligence on the part of doctors of Mata Chanan Devi Hospital, C-1, Janak Puri, New Delhi, in the treatment of complainant's wife Smt. Sunita Abrol, resulting in her death on 29.06.2019, was confirmed by the Delhi Medical Council.
- (iii) The Order of the Executive Committee in complaint No.3243 of Shri Aniket Garg, r/o- D-311, Dispensary, Bahajanpura, Delhi-110053, forwarded by the ACP/PG Cell for Dy. Commissioner of Police, North-East District, Delhi, alleging medical negligence on the part of doctors of Swami Dayanand Hospital, Shahdara North Zone, C-Block, Dilshad Garden, Adjacent Landmark : IHBAS cum GTBH, UCMS, New Delhi, Delhi 110095 and GTB Hospital, Dilshad Garden, New Delhi-110095, in the treatment of complainant's mother Smt Mithlesh Garg, resulting in her death, was confirmed by the Delhi Medical Council.
- (iv) The Order of the Executive Committee in complaint No.3522 of Shri Sushil Khatri, s/o Shri Umed Singh Khatri r/o N-8, Satyawati Colony, Delhi-110052, forwarded by Dy. Commissioner of Police North District Delhi, alleging medical negligence on the part of

Nazar Kanwar Surana Hospital, in the treatment of complainant wife Deepmala, was confirmed by the Delhi Medical Council.

- (v) The Order of the Executive Committee in complaint No.3680 a representation from District Consumer Disputes Redressal Commission I (North District), Govt of NCT of Delhi, Delhi, seeking medical opinion on a complaint of Shri Hari Narayan Prasad, r/o-Khasra No.649, Numberdar Colony, Konark Residency, Burari, Delhi-110084, alleging medical negligence on the part of doctors of Indraprastha Apollo Hospital, Sarita Vihar, Delhi Mathura Road, New Delhi-110076, in the treatment administered to complainant, was confirmed by the Delhi Medical Council.
- (vi) The Order of the Executive Committee in complaint No.3306- The Delhi Medical Council has taken a suo moto notice of a prescription dated 19th April, 2021 of Ananya Health Care, issued by you wherein you have prescribed ayurvedic medicines, in violation of medical ethics, was confirmed by the Delhi Medical Council.
- (vii) The Order of the Executive Committee in complaint No.3520-a representation from Police Station I.P. Estate Delhi, seeking medical opinion on a complaint of Shri Raj Kumar, alleging medical negligence on the part of doctors of Lok Nayak Hospital, in the treatment administered to complainant's wife Smt. Neelam, resulting in her death on 22.04.2021, was confirmed by the Delhi Medical Council.
- (viii) The Order of the Executive Committee in complaint No.3284-a representation from Police Station Kalyanpuri, East Distt., Delhi, seeking medical opinion on a complaint of Shri Babu Khan, s/o Rahishuddin, 17/203A, Jhuggi Kalyanpuri, Delhi-110091, alleging medical negligence on the part of Dr. Ashutosh Kumar, in the treatment administered to the complainant at Geo Hospital, Plot No.3, Madhu Vihar, Khora Colony, Opp. Mayur Vihar Phase-III, Ghaziabad (U.P.)-201020, was confirmed by the Delhi Medical Council.
- (ix) The Order of the Executive Committee in complaint No.3720 of Shri Amit Garg, r/o-68 Brothers Apartment, Patpar Ganj, 16 I.P. Ext, New Delhi 110092 against Metro Hospital, 21 Community Centre, Preet Vihar, Delhi-110092, was confirmed by the Delhi Medical Council.
- (x) The Order of the Executive Committee in complaint No.3707 of Shri Sandeep s/o Shri Mahinder Singh r/o H.No. 121 Village Kirari Suleman Nagar, Delhi-110086, against doctors of Aruna Asaf Ali Govt Hospital, was confirmed by the Delhi Medical Council.
- (xi) The Order of the Executive Committee in complaint No.3050 of Suraj Sharma s/o Ram Prakash Sharma, r/o H. NO. 1567 Shastri Nagar Delhi-110052, alleging professional

misconduct on the part of doctors of NKS Hospital, Gulabi Bagh, Delhi, was confirmed by the Delhi Medical Council.

- (xii) The Order of the Executive Committee in complaint No.3686-a representation from Police Station New Friends Colony New Delhi, seeking medical opinion on a complaint of Shri Ishrat Noor s/o Late Mohd. Noor r/o 18, 3rd Floor, Viswakarma Park, Laxmi Nagar, New Delhi-110092, alleging medical negligence on the part of Dr. Dixit Thakur, Dr. Ankur Gupta, Dr. Naman Bansal of Bansal Hospital A-1, New Friends Colony, New Delhi-110025, in the treatment of complainant's daughter Ms. Sadaf Noor, resulting in her death on 13.12.2021, was confirmed by the Delhi Medical Council.
- (xiii) The Order of the Executive Committee in complaint No.3537 of representation from Police Station Shalimar Bagh, seeking medical opinion on a complaint of Shri A.K. Gupta s/o late Shri Hari Ram Gupta, r/o 549-B, Rishi Nagar, Delhi-110034, alleging medical negligence on the part of doctors of Fortis Hospital, Shalimar Bagh, Delhi, in the treatment of complainant's brother Shri Sanjay Gupta resulting in his death, was confirmed by the Delhi Medical Council.
- (xiv) The Order of the Disciplinary Committee in complaint No.2360 of Shri Vishwajeet Kumar s/o Shri Mithliesh Kumar Singh r/o S2 Plot No. 34, Vikram Enclave, Shalimar Garden Sahibabab Ghaziabad, UP 201005, alleging medical negligence on the part of doctors of Max Hospital, Patparganj, New Delhi in the treatment of complainant's mother late Sunaina Devi, resulting in her death on 11.01.2018, was confirmed by the Delhi Medical Council.
- (xv) The Order of the Disciplinary Committee in complaint No.2775- a representation from Police Station, Najafgarh, New Delhi, seeking medical opinion regarding death of baby Deepanshu, allegedly due to medical negligence in the treatment administered at Metro Hospital, Chawala Stand, Gurgaon Road, Najafgarh, New Delhi, was confirmed by the Delhi Medical Council.

The Council also confirmed the punishment of removal of name of Dr. Ajay Singh Pundeer (Dr. Ajay Kumar Singh, Delhi Medical Council Registration No.11399) for a period of 30 days awarded by the Disciplinary Committee.

The Council further observed that the Order directing the removal of name from the State Medical Register of Delhi Medical Council shall come into effect after 60 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (xvi) The Order of the Disciplinary Committee in complaint No.2726 of Mohd. Mohsin, r/o- 1696, GaliTakhti Wali, Sui Walan, Daryaganj, Delhi-110002, alleging negligence in the preparation/examination of Transthoracic Echo–Doppler report of complainant’s son Mohd. Arhan by Dr. M.K. Gupta and Dr. Avinash, Focus Imaging and Research Centre, Pvt. Ltd., C-10, H-10, Green Park Extension, New Delhi-110016, was confirmed by the Delhi Medical Council.
- (xvii) The Order of the Disciplinary Committee in complaint No.2743 of Shri Abadul Haque, P- 1, 33/1 Batla House, Jamia Nagar, New Delhi-110025, alleging medical negligence on the part of doctors of Dr. M.A. Ansari, Health Centre, Jamia Millia Islamia, Jamia Nagar, Okhla,, New Delhi-110025, in the treatment administered to complainant’s son Master Imamul Haque, resulting in his death on 05.11.2017 at Indraprastha Apollo Hospital, Sarita Vihar, New Delhi-110076, where he was subsequently received treatment, was confirmed by the Delhi Medical Council.
- (xviii) The Order of the Disciplinary Committee in complaint No.2742 of Smt. Vinita Rai, r/o- C- 151, Ground Floor, Near Mata Diary, New Ashok Nagar, Delhi-110096 forwarded by the Directorate General of Health Services, Govt. of NCT. of Delhi, alleging medical negligence on the part of doctors of Apollo Hospital in the treatment administered to complainant’s son Master Veer Pratap, was taken up for confirmation before the Delhi Medical Council.

Whilst confirming the Order of the Disciplinary Committee the Council observed that in facts of circumstances of this, the punishment of warning awarded by the Disciplinary Committee to Dr. Mohit Jain, is not warranted.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (xix) The Order of the Disciplinary Committee in complaint No.3640- a representation from Dy. Commissioner of Police, Central District, Delhi, seeking medical opinion in respect of

death of Smt. Lalita and her Foetus, allegedly due to medical negligence on the part of doctors of Indira IVF Hospital, South Patel Nagar, Delhi, in the treatment of Smt. Lalita, resulting in her death on 26.03.2022 at Sir Ganga Ram Hospital where she subsequently received treatment, was confirmed by the Delhi Medical Council.

- (xx) The Order of the Disciplinary Committee in complaint No.2785 a representation from Dy. Commissioner of Police South East District Sarita Vihar, seeking medical opinion on a complaint of Shri Biswajit Mohanty r/o Prateek Laurel, Sector-120, Noida, alleging medical negligence in the treatment of complainant's wife Smt. Monisha at Apollo Cradle Royale, R-2 Nehru Enclave, Kalkaji, New Delhi-110019, resulting in her death on 25.06.2018, was confirmed by the Delhi Medical Council.

Dr. Raghav Aggarwal recused himself from the proceedings.

The Council also confirmed the punishment of removal of name of Dr. Vishakha Munjal(Delhi Medical Council Registration No.8393) for a period of 15 days awarded by the Disciplinary Committee, with a direction that Dr. Vishakha Munjal shall undergo 12 hours of Continuing Medical Education (C.M.E.) on the subject related to 'P.P.H. Management', within a period of three months from the date of the Order and submit a compliance report to this effect to the Delhi Medical Council

The Council further observed that the Order directing the removal of name from the State Medical Register of Delhi Medical Council shall come into effect after 60 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (xxi) The Order of the Disciplinary Committee in complaint No.2779 of complaint of Shri Mukesh Sehgal r/o C-9/79, Sector-5, Rohini, Delhi-110085, alleging medical negligence on the part of doctors of Fortis Hospital, Shalimar Bagh, New Delhi, in the treatment administered to the complainant's wife Smt. Sunita Sehgal, resulting in her death on 4.3.2018, was confirmed by the Delhi Medical Council.

Dr. Arun Gupta recused himself from the proceedings.

The Council further confirmed the punishment of warning awarded by the Disciplinary Committee to Dr. Brijesh Yadav (Dr. Brajesh Yadav, Delhi Medical Council Registration No.45402) and Dr. Pawan Chauhan (Delhi Medical Council Registration No.17995).

The Council further observed that the Order directing the issuance of warning shall come into effect after 60 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (xxii) The Order of the Disciplinary Committee in complaint No.3573- of Shri Satish Chander Pasricha, r/o- 1/207, 1st Floor, Subhash Nagar, New Delhi-110027, alleging medical negligence on the part of Dr. Anil Laul of Human Care Medical Charitable Trust (Manipal Hospital), Sector 06, Dwarka, New Delhi-110075, in the treatment administered to complainant, was confirmed by the Delhi Medical Council.

The Council further directed that Order dated 02nd August, 2023 of suspension of name of Dr. Anil Laul (Delhi Medical Council Registration No.13807) and Dr. Partha Sarathi Goswami, Medical Superintendent of Manipal Hospital during the pendency of the disciplinary enquiry, be also revoked, since the Disciplinary Committee proceedings have been concluded.

- (xxiii) The Order of the Disciplinary Committee in complaint No.3276- a Court Order dated 23rd March, 2021 in Civ/DJ No. 61329/16 in the matter titled "Intec Capital Ltd. Vs Raj Lab Diagnostic Centre", in which certain observations have been made by the learned Addl. District & Sessions Judge-05 (West), Tis Hazari Courts, Delhi against Dr. Angad Singh, was confirmed by the Delhi Medical Council.

4. To discuss about the Minutes of the Special Committee for regularization of Temporary Staff.

The agenda was deliberated in detail and Council directed that the same be again taken up in the Next Council Meeting.

5. To discuss about the Minutes of the Anti-Quackery Committee.

The minutes of the meeting of the Anti-Quackery Committee of the Delhi Medical Council held on 06th September, 2023, which were circulated to the members present (**appended herewith as annexure 'B'**, were confirmed.

6. To discuss about the Minutes of the Finance Committee.

The minutes of the meeting of the Finance Committee of the Delhi Medical Council held on 06th September, 2023, which were circulated to the members present (**appended herewith as annexure 'C'**, were confirmed.

7. To discuss digitalization of the records of the Delhi Medical Council with regard to outsourcing of records.

The members discussed about the scope of digitalization and deliberated that tender/quotation to be called from vendors preferably Government Agency having experience in the field of digitalization of records.

8. Any other item with permission of Chair.

(i) The Members observed that since the Council has established a reasonable corpus; steps/initiatives be taken for acquiring land or requesting the Govt. of NCT of Delhi for the same for building the office of the Delhi Medical Council. In this regard, a Land and Building was constituted, comprising the following members :-
